Dear Tom,

Bill is finally home! Weak but getting around. I'm back in dialysis after the first fistula planted in my right arm had to be cleaned twice and then removed, another implanted, and that takes close to eight hours Mondays, Wednesdays and Fridays. Have less time, am less able.

There has to have been someone in the role in which you say Morales was. Whether he is the one Garrison had in mind I doubt. Not an uncommon name and what others did not make up for him Garrison made up for himself.

As you can see, the typewriter is fixed but is not what it was. But it has also had much use. A dear friend found me a duplicate of it more than 2,000 miles from where he lives and it has gotten here. I'll try it when I have to change this ribbon. Ribbons now are never fresh, begin on the pile side.

Hope the chemotherapy did what it was hoped!

With all the extra expenses we have had, Bill in the hospital or nursing home for nine months, me in two hospitals or a n. home for three months, we have not given any thought to spending any money that we should and would like to be able to on the house.

Interview fine if it requires no travel.

Dear Harold and fil,

So good to hear from you! I have phoned many a time to get no response. I am elated to hear that you are alive and that fil is recovering from all that tedious surgery and subsequent hospitalization!

What is this about someone breaking into your house? Did I read that correctly? What did they take? If they were after your research files, I guess they did not know that you keep the whole truth about the assassination inside a mayonnaise jar buried in the back yard! In any case maybe it was David Sifton, coming back to get what he didn't get before! Anyway Harold I thought that I read that in your letter, the type ribbon may have caused me to mis-interpret.

Me myself! I am off of chemotherapy after nine months of hell. It, the interferon, did not work, however I feel good! I went on a heavy regimen of herbs and vitamins. I drink 1 1/2 gallons of water a day. I eat many fruits and vegetables, no red meat or pork. I work six days of the week, seventy two hours! I sleep no more than six hours a night. I also smoke like a chimney! Harold I probably will not see eighty six, however I'll plan to live my old age thru you! I am so glad that you are O.K. and willing to continue to work!

- I discussed with you the work on your house, and prior to this very busy season, I was attempting to get your response to setting up some tentative time to help you out. I started calling a while back. Yes, I guess I could have written. However, we were both sidelined with health problems. Maybe we can do something to help out come fall '99. Right now I am very jammed with home restorations in Western Bowdoin county. Please keep it in mind.

On my historical research, I have had some very interesting developments while working with retired members of Army counter intelligence, and former Defense intelligence staff. P Harold, I know you probably get a hoot out of hearing this stuff from various so called researchers, but this is not foolish prattle, or bullshit. One gentleman in particular has proven to be most informative concerning David Sanchez Morales. He was a D.I.A. attache' and involved with Allende's down fall. (the gentleman former, not Morales!) He has in confidence confirmed that Morales did orchestrate Allende's assassination, along with Che' Guevara demise too. He has definite information concerning Morales in other assassinations. He feels, and he will not detail why, that David Morales engineered the Dealey Plaza event. Harold this guy is very well respected and I can't

corroborated his career and contacts through normal channels. In fact a lot of this is detailed in "PRICE OF POWER" by Hersh. This may sound dramatic to you, but in a quiet, but terse voice, he said the reason he is alive today is that he's kept his mouth shut for years and plain and simple, will continue to keep it shut. We did not meet by accident, and we have built up mutual trust. He in fact knew David Atlee Phillips quite well and very adamantly, but quietly states that eventually much of what we don't know will be soon see light of day. Again this man was at the top of Defense Intelligence Agency ladder. He dealt directly with Kissinger and Nixon on allende, and was considered the foremost authority on South American politics. Harold of all the people I have spent time with or interviewed or agreed to keep a confidence with, this man appears genuine and not, definitely not, a flake or poser in any way. His military record and DIA/CIA records are somewhat available. Anyhow you may remember Morales from Garrison who never really followed up the lead to the fullest. Again, Morales was to be subpoenaed, he never made to House Assassinations Committee dying of heart attack at fifty three. Of course this information is not new, and I'm not saying that. My contact is new in the sense he has never spoken

in any circles or divulged this to anyone. He did an extensive interview in early 80's with Seymour Hersh on Chile for "PRICE OF POWER". Harold he is definitely in possession of knowledge concerning at least peripheral workings of Dealey Plaza's mystery, I'll tell you more at some time soon!

At some time I would be greatly honored if you were to agree to an interview, if not lengthy then detailed concerning your work, your life and after all your ~~some~~ summation of this whole quirky historical event! Harold I "ain't" a ~~flack~~ flack or a flake, I truly believe that the American people if not the world would be very interested in what you have to say now that near thirty six years have passed, I have nothing but admiration and respect for all you have done and all you stand for. I could say that you owe it to our American posterity, but, you owe no one anything, I firmly believe that you are in possession of a wealth of information that presented in an interview format could greatly enrich our perspectives. You have granted interviews before but never can I recall by someone with a knowledge of the assassination or someone who knew your work. I have ~~sp~~ spent so much time on this, lets set the record straight one more time! From Harlan County to the Paris case to the Warren Commission to M.L.K. to Garrison's abortion to Oliver Stone's travesty to Harold Weisberg's

thesis on his years. Harold what  
a legacy, or rather what an addition  
to a legacy a well planned, to the  
point interview could be!

Please think about it,  
Sylvia Meagher wasnt able to do what

me. It could be a parting shot at
