Dear Cyril,

Lesar may phone you about this. I told him I'd write you. So you can understand I begin with an explanation.

Long-overdue NEVER AGAIN! is in page proof. It was scheduled for being in the stores in a month or less. Corrections now being made may delay it slightly. It is a very, very powerful book. Those who do not love Specter should love it! With any attention he will have some troubling problems.

As I wrote the book, as usual, I sent ^{Don} Wrono xeroxes of the chapters as I did them. He was so impressed that without telling me he retyped them on his computer. I first knew when he sent me the first half-dozen or so retyped.

Richard Gallen was an old friend, had been a very good one. When he visited the July 4 weekend I told him about it. He said he was interested.

He is a successful publishing lawyer. He represents many smaller publishers and the distributing company that distributes their books. He also copublishes from time to time. He is office ^d on the same floor as Carroll & Graf, one of his clients. He had most of the manuscript before the end of that year. ¹⁹⁴² Wrono was busy and could not ^{than} get to retyping the last few. I expected the book to appear, after ~~he~~ ^{Gallen} told me he liked and would do it, by the middle of 1993. It could have appeared then without any rushing of any special effort. If it had and had gotten any attention at all before the flood of atrocities to mark the anniversary, it could have made a big difference with Poser and others who would have followed it. I have yet to learn why it was delayed. They and several times thereafter.

With the delay I was able to add to it. Of special importance, I think, is the afterword in it.

Meanwhile, when Gallen heard I was doing what appeared as Case O, he and Herman Graf were interested in that. When it was published it was ^y gotten. ^{an} The entire and entirely different book was eliminated from it. They did not even correct typos I'd picked up. There are other flaws that cannot be excused in normal publishing. They spent not a cent on advertising or promotions. If they sent out a single review copy I've not heard about it. The media ignored it entirely. But my mail on it is exceptionally good, after a year. Yesterday five letters! More than usual now but all fine.

When I knew that NEVER AGAIN! was being manufactured I wrote with some suggestions for getting it attention. In a month not even acknowledgement of that letter. One of my suggestions was that Gallen, who is the copublisher, hold a press conference in his office and explain it is for me because I cannot travel and give out copies of some of the documents and pictures on which it is based.

Thinking about this strange silence I got the idea that we could hold the press conference in Cesar's office. Randy Robertson has done some new and solid work on the autopsy X-rays. It confirms what I first postulated in 1966, in Whitewash II, of two bullets to JFK's head. As you may recall, I carried this forward in Post Mortem with what cannot be assailed. But was ignored. He declined. He wants his first attention to be in a professional journal.

I also had in my ^{AMP} ~~you~~ and Chip Selby for that conference. Selby because of what he did not use of his Dolce interview. I'd told Chip what I knew of what Dolce had told ~~Sp~~ Specter, as in part I brought to light in Post Mortem, where to find him in Florida, and Chip drove there and interviewed him on a video cassette. Chip gave me the transcript and permission to use what is not in his documentary. It is powerful ~~stuff~~, too. So I wanted him to make a cassette of just what I used and show it.

He'd told Specter that going back to the Civil War it is a known impossibility for the official explanation of the Connally wrist wound. Specter asked him to make tests, Dolce did that at Aberdeen, they confirmed what he said, and Specter ignored that and him in the report. *He was not called as a witness.*

Dolce was the top consultant on wounds. He was to have been the consultant on all wounds of all VIPs. But the Army did not call him on the JFK case. It ignored him and his role. (I think Dolce was then a colonel. He is a doctor.) I have what ^{adds} much ~~to know~~ ^{what you} about the Matzenbach memo to Moyers I got from the DJ and got some little attention with the FBI's general disclosures of 1977-8. This more includes Hoover's ^{11/24/63} agreement, which makes it a de facto conspiracy not to investigate the crime itself (how NEVER AGAIN! starts) and I have that in an unknown FBI record made by an assistant director. To that I add a prima facie case that LBJ knew and agreed the night of 11/24/63. Or, LBJ was de facto part of that conspiracy!

Meanwhile, the book, which uses the JAMA whoring with our history as a skeleton to flesh out, does all those whorings like you cannot imagine. It makes a solid case of ~~names~~ irrefutable perjuries. Plural, yes, plural.

A case I think doctors ^{of} should be up in arms about JAMA ^{and} about to the AMA.

So, the question is whether you are willing to be part of the press conference. Jim and I did not discuss his being part of it. I assured he would want to be. He was my lawyer in all those FOIA lawsuits from which I got much of what I use. He was to phone ~~me~~ Selby last night. (The LBJ stuff is not in DC records. A friend got it for me from the LBJ library. I have it in unknown Secret Service records this friend got for me. Thus is it not in the disclosed phone record transcripts because it was prior to those taped calls.)

I'm sure the time can be arranged to be convenient for you. It would be after you get and read the book. I do hope it interests you. (I've completed the sequel but am not offering it to those people after these experiences) Best,
