Ned and Gary,

I am not making general distribution of the enclosed letter to Cyril Mecht, to which I will return.

This morning, early, I went into the post office to be certain that the last part of the last part of Ph got out to hed today. It may reach you before this, but because it is so large a package, it may also, by accident, at some point along the line be tossed into a bag of other than first-class mail.

I presume Ned will have no objections to being classified as a scholar or student!

In the enclose long and painful letter to 'yril, for whom I have long had high regard (even if he did mis everything in the panel report I had to tell him what it means, for he is very busy, making lots of money being very busy, and like so many skimmed it in haster in fact, I even made the copy of it for him), I have avpided spelling out wherein the danger lies. There are number of reasons for this. First, I don't know what his politics are, and that can be relevant. He is the county coroner. I don't know what he thinks about many things, like the Konnedys. He may be a kennedy-hater. I have met him in person but once. And I want him to think it out for himself.

Only one of the possibilities for the greatest counter-productivity, one that, if the government decides the time has come - and boy, could it have political value to the needing Mixon! - is that what he is up to provides a perfect mechanism for what I go into is almost all my writing in one form ar another, as I have just come to realize in going over Ph., is what I make explicit in the chapter of the new last part, Hades- not Camelot.

They can let "yril see the real things (or those that still exist) and let him come out and say the whole thing is a can of worms, and the full responsibility will be pinned on the Kennedys, for it is under that contract that he is seeking access. (I have avpided the likelihood that "ohn Nichols, who is morse, may do the same thing, but with Nichols there is little chance because they have refused him in suit).

Suddenly nobody else is at fauly. Hoover has another halo. The Commission lawyer-villains become martyrs to the awful Kennedys. Teddy, personally, is ruined or at best severely damaged. He is the one responsible once obby got killed. Read the contract.

We are well past the point where the question is merely was the Warren Report right. It has been years since anyone even suggested that to me. obody believes it and from the very beginnin, few did. We critics had much less influence on opinion that most of us like to think. People didn't believe it to begin with. All the critics did was make is less difficult for people to say. I learned this early on the many talk shows I did. People, for the most part, never believed the official fiction. We just reduced their inhibitions. I think we really changed few minds. Ty own and very extensive correspondence reflects this, too. So, we should not be kideing ourselves on this point.

But the immediate question is there does this leave us? Let me address this in two ways. It makes a real\* meeting and dissussion with Teddy's people more urgent. Cyril can take the next step of the 29th. I would prefer to do this this with you, if that is possible. \*gis is why, in one of the notes, I asked if you expect to be near here soon. It is also why, afte so of a time, I wtote my Senator. I've sent you a copy of that letter. \*\*Mexitix\*\* He is an old friend, and he did try to help me in 1965, when he learned his lesson. I think he will see me, unless something I can't anticipate has given him more fear than I know of. It this is the case, and the 29th gets too close, I will stop off and talk to his wife, who is a great gal.

On the other hand, I have not in any way exaggerated the possible beneficial effects this can have on the commercial possibilities of any book. If this comes of as is possible, with the publicity it will serve federal interests to generate, any current books ill go craxy. From a purely se; fish point of view, If we can have any version of Ph ready at that time, its success is virtually assured. What a helluta way to become a success!

Monayou can also understand why I took the time to write "yle Stuart when I was trying to explore the possibility of readhing him indirectly. It is not only to interest him in the potential of the abrdigement you are preparing (and 1 hope can now rush even more. The last link in all of this I didn't get until Tuesday, and then only by accident.

as I hope you can xmm realize, I hardly have time to stop and think everything through now. It is always more dicturbing when those who whould be our friends turn out to be our worst enemies. You can, for example, now understand why, instead of writing you in full immediately, see why I had to formish going over the older parts of the book. If 'yril

plunges shead, which I regard as the creater possibility, for it is his ego and ambition, not his fine mind, that is now in control, it is even more urgent that ar counterweight be immediately available. (Actually, Cyril has not spent much time in real work on the subject. It is no deprecation to say that he keeps busy making money, His knowledge is narrow, limited from that I've been able to detect, to the defects on the autopsy itself. He is making so much he has been forced, as he explained to me in telling me why he would not be an expert witness in my oictures suit, to give up some very profitable arrangements.) This and his fine reputation makes him perfect for government misuse. And, of course, his record before the forensic-medical society and in fink's book of disagreement with the mit.

As I think shows, all of this is deeply disturbing to me. And there are other things I must do. While IId prefer not to discuss this further bytchone, if necessary, I will.
