Weisberg Wallops Whitewashers

"At what point is the press going to remember its near-sacred function in this country? At what point are the writers, editors and agencies to become disgusted with their plimpery and recapture their integrity and that of our country with it? When will you ask, 'suppose the Report is wrong?' When will you even make an honest effort to find out?"

This castigaton of the American press' role in covering up the facts of the Kennedy assassination is from a letter to Julius Frandsen, Vice-President of UPI, by Harold Weisberg, author of "Whitewash," a book critical of the Warren Commission Report.

Weisberg's letter dealt mainly with an article, issued by UPI and published nationally last month, written by Merriman Smith, UPI White House reporter and winner of the 1964 Pulitzer Prize for his eyewitness reporting of the assassination.

Weisberg noted that in his recent article Smith placed himself "a few hundred feet from Kennedy when he was shot," at the famous underpass from which shots were heard by some witnesses and located in front of the President's car; but that in his original story from Dallas on the day after the shooting, he stated that he was "150 or 200 yards behind 'Kennedy's limousine."

In both stories Smith states that there was not the "slightest doubt" in his mind that the shots came from behind him, meaning that according to his original account, the assassin could not have been in the Texas Schoolbook Depository, where Oswald is alleged to have been at the time.

Weisberg's letter to Frandsen declared, "If (Smith's article) is a monumental intellectual dishonesty

'Whitewash' One and Two Almost Due

Harold Weisberg, author of "Whitewash," has announced the publication of two additional books on the assassination of President Kennedy.

The first of these, due to be released this month, is entitled: "Whitewash II: The FBI-Secret Service Cover-up." Weisberg describes it as "the first book based on the until-now secret files of the Warren Commission."

The third in the series of books by Weisberg is planned for February publication. It will be called, "Whitewash III: The Archive." The author's pre-publication statement predicts that this work will "create its own major sensations."

Whitewash III will "consist of photographic reproduction of those official documents and pictures referred to in the text of Whitewash II, NEVER BEFORE SEEN OR PUBLISHED, others which could not be drawn upon in the text,
