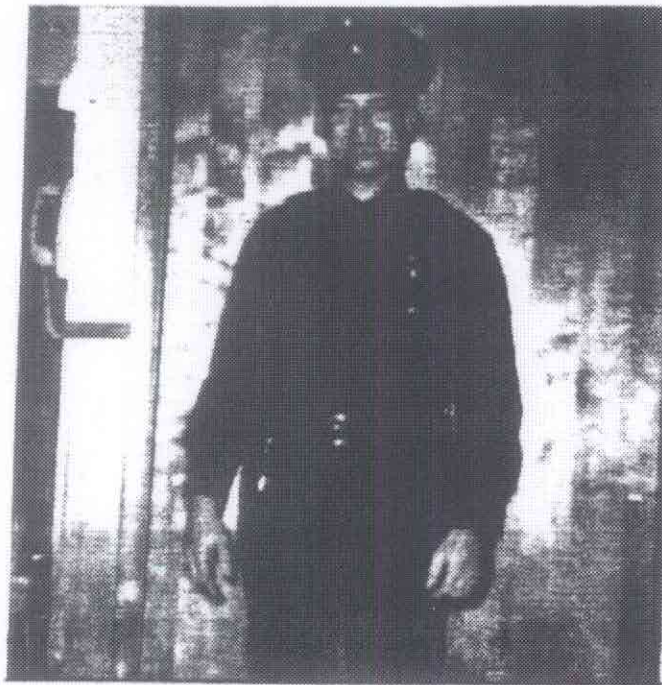


U.S. Navy Secretary of the Navy, James V. Forrestal, (center) presiding over a meeting of the Joint Chiefs of Staff, 1942.

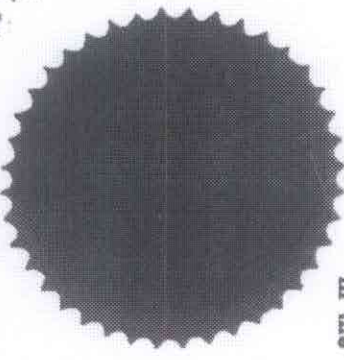

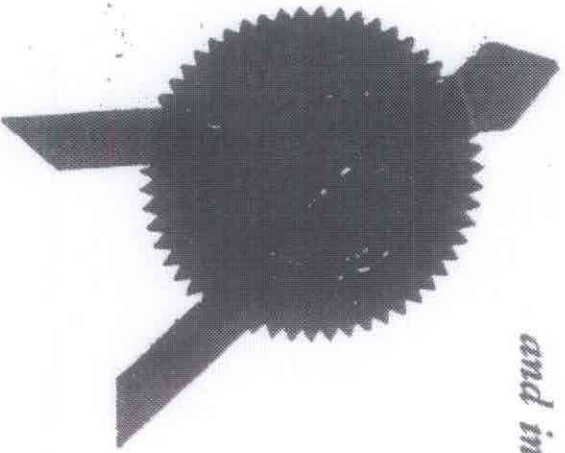
