Thank you for finding Oswald in New Orleans.  
I knew you could to it. I am enclosing a check for \$26.25.

I hope you are well. The conference in Dallas was a good time. I found there to be more agreement than disagreement in where we should go from here, as well as the divergent theories.

There was one presentation that was astounding. Personally, I believe in him and his information. He is bringing his information to the government first then he said he will make his stuff available for others to study.



Thank you very much for the cassette and you letter of the 8th.

My wife found the xerox master of Oswald in New Orleans and we've had copies made.

They are on 8 1/2 by 11 paper, <sup>two</sup> ~~to~~ books pages to one side of each sheet, and with what I've been told is a durable binding and a protective plastic protective cover. I have not seen them because they weigh more than I am permitted to lift so they are in the trunk of the car until someone is here, probably today, to carry them in for me.

My wife found them by accident!

On a few of the pages some of the printing is not as clear as we'd like but in those few pages it can all be made out well enough.

The cost is \$26.25 including insured postage.

I hope you are enjoying the conference and that your thinking will not be corrupted by the nuttiness of the speeches and the self-serving statements by those who have their own agendas, of which I heard by phone only yesterday, from someone there.
