13. HARGIS, Officer Bobby W.:

\*✓ 64293-296 Motorcyclist to left rear of limousine was spattered with blood. Thought shots came from knoll. Address: 1818 Adelaide, Dallas.

14. HESTER, Charles:

22H841 On North side of Elm, thought shots came from "Immediately behind us." His wife was with him. Address: 2619 Keyhold Street, Irving, Texas.

15. HILL, Mrs. Jean:

\*✓ 64205-23 Standing on South side of Elm, heard 4-6 shots, with difference in sounds. Thought shooting was from grassy knoll. School teacher, good witness. Address: 9402 Bluff Creek, Dallas.

16. HOLLAND, S. M.:

\*✓ 64239-248 Has consistently stated shots came from knoll, but his testimony has serious weaknesses. (e.g., from his position the knoll and TSBD were in a straight line.) Probably better to avoid him as a witness.

18. LOVELADY, Billy Nolan:

Standing on TSBD steps, thought shots came from knoll. Has recently moved, and has been in hospital. (I think Penn Jones has address.) Penn says he has now changed his story making it consistent with Warren's.

19. MOONEY, Luke:

\* ✓ 34281-90 (Deputy Sheriff). Thought shots came from knoll area and ran in that direction. Address: Sheriff's Office, Dallas.

20. NEWMAN, William & Gayle:

\* ✓ 22 H842  
24 H219 Standing North side of Elm, thought shots came from behind. Dramatic picture by Art Rickerby (LIFE) shows Newmans lying on ground looking back towards the picket fence. Address: 718 W. Clarendon Street, Dallas.

21. ROWLAND, Arnold Louis:

\* ? 24 H 224  
26 H 166 Saw two men in TSBD 6th floor before assassination and thought shots came from the knoll area. ADDRESS: 3026 Hammerly Street, Dallas.

22. SHELLEY, William H.:

\* ✓ 6H327-334  
24 H 226 Standing in TSBD entrance, thought shots came from the west. Address: 126 S. Tatum, Dallas.

23. SMITH, Edgar Leon:

Standing near Elm/Houston corner, thought shots came from the knoll area. Police Officer, Traffic Division.

24. SMITH, Joe Marshall:

7H 531-9 Thought shots came from the "bushes of the overpass". Police Officer, Traffic Division.

25. TAGUE, James Thomas:

Standing by underpass on Main Street. Was hit on cheek by a ricochet. Thought shooting was from "over at monument to his left." Salesman for Cedar Springs Dodge. Address: 700 West Euless, Euless, Texas.

27. WALTHER, Carolyn:  
\* 24 H 522 Thought shots came from TSB. but saw 2 men in...  
(was featured on CBS "special".) Address: 4118...

28. WEITZMAN, Seymour:  
\*? 7H 105-169 (Deputy Sheriff) Thought shots came from knoll. Ran  
up knoll and scaled fence. Then ran to TSB. and found  
rifle on 6th floor. Address: 2802 Oates Dr., Dallas.
29. WILSON, Steven F.:  
\*V 224 685-6 (Vice President of Southwest Division of Allyn &  
Bacon, Inc.) On 3rd floor of TSB, thought shots  
came from "west end of building or colonnade".  
Address: 903 Carney Drive, Garland, Texas. (mentioned  
in "Rush to Judgement", FBI tried to get him to change  
his story.)
30. ZAPRUDER, Abraham:  
\*V 7H 569-576 Standing on knoll. Initial statement to Secret Service  
said shots came from behind him. Later he changed his  
story. Address: 3909 Marquette, Dallas.

Nearly all of the above-listed witnesses gave testimony tending to corroborate that the shooting came from the Grassy Knoll.

To make a case consistent with the concept of crossfire, one would possibly need to introduce other witnesses who said the shots came from another direction, e.g., the Book Depository.

My suggestion would be to call JOSIAH THOMPSON as a witness. (He is a philosophy professor at Haverford College, Philadelphia, Pa.) He has done an analysis of the testimony the eyewitnesses which strongly indicates shooting was done from at least 2 directions. A book by him is due out this Fall.
