I think this led you to fudge and be value so that you would nkt make a mistake hatever the explanation, this writing should be firm, straightforward, unequivocal and should exude confidence.

There may be more but I'm getting tired and it does not come to mind. and I've just realized that after I got home early this morning and immersed myself with this I gorgot to wish LiZa happy 80th. I'll not forget now and we'dh have a sprt-of celebration of it at Hana's this evening.
