Dear Harold;



Dear Payl, Glad to get your 11/1 and Penn's newsletter. I'll read it when I rest. I'll probably go out and dig out the inlet to the pond a little more. I'm making fair progress & the exercise is good. I'm pulling the wet dirt to fill up low spots so I can mow more while riding next summer. No, I'm not overdoing it... I don't recall the name but one of your Pacifica people did call me up, did give a long interview - more than a half-hour, and did say it would be aired soon... I don't recall what carbons I've been sending you. Mailed a fat envelope this a.m. We are going to seek to use a provision of the Act to obtain a waiver of all costs in the King case. We'll still have considerable ones if we do succeed on that, like the depositions in the Spectro case. If the FBI keeps its word I'll eventually get ever paper it has on King. Tell Wexler if you can. They will stonewall as much as they can but Jim and I expect an Order from the judge this week giving them a certain amount of time, less that their 44 weeks four of which have passed. We spent much of yesterday planning what we'll do in the contingencies we can anticipate. This at the least will make a fantastic archive... I'll be in Wisconsin most of next week for speeches and seminars... We have the beginning of winter. Few snow flurries this a.m. It got cold enough to kill some plants & overlooked the 10 days I was visiting my mother. They were on the closed-in porch but it was that cold. Keeping up with the mail is about all I can do besides what is necessary for the litigation and going over the records I get. They are wise to flood me. I've been waiting for them to tumble to this. It keeps me from ritting now.
