NEW ORLEANS STATES ITEM, RED FLASH EDITION, SEPT. FOURTEEN INSTANT, REPORTED THAT THE OFFICE OF DA JIM GARRISON HAS FILED ITS ANSWER TO THE LATEST ATTEMPT BY ATTORNEYS FOR CLAY L. SHAW TO HAVE THE CONSPIRACY INDICTMENT AGAINST SHAW THROWN OUT. THE ARTICLE REPORTED THAT THE MOTION TO QUASH THE INDICTMENT ALLEGED THE VENUE FROM WHICH THE GRAND JURY THAT INDICTED SHAW WAS DRAWN FROM A POOL OF LESS THAN SEVEN HUNDRED FIFTY NAMES IS IN VIOLATION OF STATE LAW. ACCORDING TO THE ARTICLE THE STATE'S ANSWER FILED YESTERDAY DENIED THIS ALLEGATION.

INSTANT ADVISING HE HAD OBTAINED A COPY OF A BOOK WHICH HAS  
JUST BEEN RELEASED ON THE GARRISON ASSASSINATION PLOTT  
ENTITLED "PLOT OF POLITICS" WRITTEN BY TWO NEWSPAPER PEOPLE,  
ROBERT JAMES AND JACK CARDLAY. MARTENS STATED THAT A  
SECTION OF THE BOOK DEALT WITH A SEARCH OF FERRIE'S  
RESIDENCE IN NINETEEN SIXTYONE WHICH STATED THAT THE  
SEARCH OF FERRIE'S RESIDENCE YIELDING ONLY SEVERAL RIFLES  
AND AMMUNITION AND MAPS OF CUBA. MARTENS SAID THE ONLY  
MAPS OF CUBA TO HIS KNOWLEDGE IN FERRIE'S RESIDENCE WERE  
MAPS HE HAD IN A BRIEF CASE LEFT IN FERRIE'S RESIDENCE.
