In general, all the books that confuse people like you that are theories presented as fact or solutions deceive and mislead you. And others.


The crime itself was never investigated officially. There therefore are no real lead to be follow.

Dear Mr. Weisberg;

That started a long list of books to read on the subject, including your book 'Whitewash', which I enjoyed very much. So much I had to re-read it in order to understand some of the material. I also saw the A+E program 'The men who killed Kennedy' and enjoyed your segments. Oh, and I saw you as well on 'The Harrison Tapes' and particularly liked your appraisal of the FBI report of the Bronson film; 'and not to recognize a building!'

Anyhow, the main reason I'm writing is because in a recent book I read 'JFK, the book of the film', I was extremely puzzled to see an article by you saying that both the A+E program, & Stone's movie were 'very bad'. Could you please fill me in a bit more on your reasons?

Ugh! I very much trust you, so perhaps you could set the record straight for me.

I have tons of other things to do, but I shall stop here, as I don't want to overstay my welcome. Would it be possible for me to write to you in the future with other questions, or just to say hello from time to time? In closing, I'd like to say
