The number of sources on your note about Harry are few and I'm glad you learned, in part because from what I've heard you are part of his tissue of a disclosure organization. He has behaved wretchedly with others and gives indication of including me in his all-included <sup>and</sup> conspiracy theories, one to kill and all the critics out to get him and ruin what he calls his work. I suspect he is <sup>ing</sup> have stuff fed to him and is so self-important he does not recognize it.

The kick on which he has been off for some weeks comes, I am sure, from a kind of illness. He then can't control himself. At other times he can be and he tries to be a nice guy. What precipitated his sick outbursts at ASK I do not know but from all reports he was very, very bad. Particularly to a very conservative lady, Mary Ferrell. She is in ill health, her husband is in terminal illness, and Harry has invented a conspiracy role for her by inventing one for her former employer, a big, right-wing law firm. She worked for them so she was a conspirator!

I fear he may be heading for even more serious problems. I regret that.

And this kind of behavior defames us all.

In addition to having much, very much time taken by him and his people, some only copies in which nobody else had ever had any interest disappeared. I can't prove a thing but it did happen and nobody else ever looked at that Lifton stuff. Which I had prepared for the historical record. The most likely possibility is that the cop, who denies it, took it and sold it to Lifton. For whom one of Harry's friends told me he was working.

It is a mess, I'm sorry about it, but I have to avoid wasting any more time on it.
