Your three pages ask about Oswald's wedding ring and wallet, about which you say he had them with him when he left them in the Payne's bedroom.

I do not recall what I said, if anything, about this but in the event you do not have all my books I enclose a list. I do recall writing about that he left there and about his arrest but not in detail.

However, I believe that you bein with incomect assumptions: that he was wearing the wedding ring when arrested and that he left the wallet there. I do not recall the pictures you refer to and cannot now take time for checking but I have no reason to believe he was wearing any wedding ring.

There is a list of what the FBI had and turned over to the Archives pursuant to the executive order of 10/31/66. Capales should be available for the FBI and/or the Archives.

There are so many things wrong with the official investigations that might if followed lead to worthwhile information but I am inclined to believe that the line you are following will not be productive or yield any significant information.

Ho a leading researcher about the assassination of John Fitzgerald Kennedy, I am twening to you in hope that you can provide me with your facts about certain issues relating to evidence put forth by the Warren Commission. I have been troubled about a number of adiscrepancies the Warren Commission overlooked and feel, that with your knowledge and access to files about the assassination, you may be able to resolve the problems it have been at a loss to answer. First of all the Warren Commission accepts the finding that on the morning of November 22, 1963. Lee Hawey Oswald prior to his departure for the T. S.B.D., deposited his wedding ring in a tea cup located on his wife's bedroom bureau and also, left his wallet in the same dresser bureau. Upon his arrest, the Warren Commission accepts the finding that Lee Harvey Oswald was in possession of a wallet containing an average I identification. My fuestion is simple. If aswald left his wallet at his wife's residence. and was lather arrested with a wallet in his possession, did the Warren Commission ever report that Uswald possessed two wallets or that the wallets in question were one and the same.

If he owned two wallets, what contents were found in the wallet left at his wife's residence. I have never been able to discover any more than the report that it Contained morey. If on the otherhand, the wallets are some and the same, how did Oswald gain access to it if he reportedly never returned to his wife's residence prior to being wrested. Have I missed something in my reading or is this a discrepancy with the Spindings wedding ring Oswald is said to have left at his wife's residence, photographic evidence shows Oswald to be wearing a ring on the traditional wedding ring while in Custody. Regain my glestion is simple. How his wedding ring? If the ring Usuald is wearing while in custody is the same one that he left at his wife's residence, did Marina bring it to his interrogaters who in turn gave it to Uswald or did she gibe it to him directly during her wisit with him at the Walles Police Headquarters. If not paw did Oswald regain possession of his wedding ring if the ring he is wearing in photographs is his wedding dung. Again did Uswald possess two

rings, one being his wedding ring and the other, to ring of some of other personal significance. If not, and the ring ashald is wearing while in custody is his wedding ring and was on his finger at the time of his would suggest to me that the Warren Commission overlooked this discrepancy.
