found it interesting.

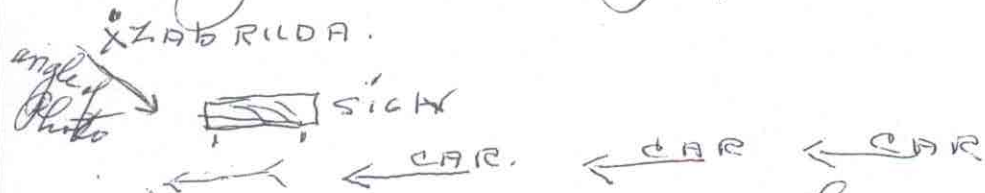
He said the case has  
now been broken someone



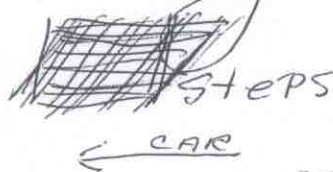
has talked in Washington
