1266-464 Undated LEE HARVEY SWALD is hardly a summary of all the CIA's information as of the time of the last info. referred to. Last entry, 5%, says says CIA had received a report from the FBI on the 9/7/62 interview with Oswald. This was from a "contact he had made with the Soviet Embassy." He wint told FBI it was to give them Marina's address. Is this in the Fain report, that they went there over the letter intercept?

1267-1031 is 12/18/63 excerot from 31/1 Wash Post reporting that Oswald had met with Priscilla Johnson. Par. 2. entirely masked. "Matters relating to foreign paking intelligence sources and methods. ...identifying an Agency dtaff employee..."

1272-1028 2/20/64 says that MxCCkty cables made available to WH, whether or not WW. WX WC had them. Indication withholding from Commission this early. Re which info it is to be given.

1273-1027 3/10/64 comment or Allen-Scott report that LHO met with Agency employees in Moscow Embassy. It then says that cable 234 says that Oswald met with Second Secretary Richard E. Snyder and "there is no indication from the dispatch that any other Government employee participated in the interview." Then it notes prior stories that Priscilla Johnson had met with Oswald. "eginning of par 4 masked, ummasked part beginning "Johnson's biographic data reflects..." Reason for withholding, which also includes Pars. 5 and 6, "intelligence methods and information" that would invade personal privacy, Midentifying an agency component and an Agency employee..." This does seem to finger Snyder and Johnson.

1261-1024 three lines quoted from The Invisible Government on Capt. Alexis H. Davison.

1289-1019 says that CIA saw galleys of Ford's book long before publication. Maskings of names probably identifies employees who do this kind of work.

1293-468 page 2 says "There is no record that OSWALD was utilized by this Agency." (Interesting in that reference is to existing record only and "this" agency.)

1294-431 6/19/64 has maskings 1st page relating to Murretts, Marilyn in particular. Page 3 has reference to "report of interview of George DeMOHRENSCHILDT" not saying by FBI and giving details of Marina's dental appointments. He here is again referred to as "George." Page 4 maskings related to Davison followed by "DAVISON was apparently never used clandestinely by the Agency." Martin Isaacs was the subject of an investigation that discloses aliases (Page 5). Page 6 reference to Bringuier does not disclose his use by agency. (This is one of series of reports on Oswald's addressbook.) Another is 1296-469. Beginning on page 2 after according to information furnished to the FBI" there is masking of half this pages and 8 pages the first of which is headed "Attachment" The lest 4 bears numbers 9-12. Tr more than 8 pages are withheld. These should be studied carefully, parti cularly what is masked. There are indications, for example, that some of the people may have applied for CIA employment or have been employed. One follows mrs. ax Clark. Another (1305-472) follows Jaggers-Chilos-Stovall. The exemptions claimed could indicate a connection. The CIA had early interest in the Martello slip (see 0 in N.O.) 1314-1036D on Garrison case refers to a Clay Shaw files. 1362-1061-A does not deny any connection with "artens. t indicates other records on him and his association with John Edward Whelen. Subject of memo David Ferrie, date 12/20/73. What was the interest then?

1363-501 says no Arcacha connection and links him only with FRD, Frents. Says the 544 camp office was of FRD, which is wrong. It was CRC and that was CRA. Interesting they tell this lie when they did support CRC until 4/63 and they report Arcacha thrown out of Frents in 1962.

In general it appears that everything is withheld because it relates to foreign intelligence. It seems that Agency cojtacts of those names may be limited to a DCS connection. That Nosenko was put through questioning again in 1/68 may be interesting. That does coincide with Garrison activity.

Some of the reviewed documents are withheld in their entirely. I have not read the index to determine the claimed reason. Some of these are in a sequence indicating a possible connection with publicating.
