Investigation was conducted regarding Marilyn Dorothea MURRET, who is the daughter of Charles and Lillian Claverie MURRET, residing at 757 French Street, New Orleans, Louisiana. Lillian CLAVERIE is the sister of Lee Harvey OSWALD's mother. OSWALD had lived with Lillian Claverie MURRET, apparently aka Mrs. "Dutz" MURRET, for a few days in 1963.
