On 8/10/63 Lt. FRANCIS MARTELLO, Platoon Commander, First District, New Orleans PD, advised that captioned individual had been picked up on 8/9/63 and charged with disturbing the peace. He said that OSWALD had been distributing literature for the "Fair Play for Cuba Committee" in the 700 block of Canal St. He said that OSWALD was desirous of seeing an Agent and supplying to him information with regard to his activities with the "Fair Play for Cuba Committee" in New Orleans.
