

CONTENTS OF THE STATE DEPARTMENT OFFICE OF SECURITY FILE ON OSWALD (CD 1114, FILE XI)

There are 27 items, generally in reverse chronological order, in this file (18H329). The document number, e.g. XI-21(4), indicates the number of pages, if known from such a notation on the document itself.

"NS" means not sent in Jan. 1967, when I asked for a copy of all items - except # 10, 25, and 27; it should not be taken to mean "not now available." "Copy" does not imply an exact duplicate, with the same markings. "Guess" really means guess. "TS" = transmittal slip. Other abbreviations are standard.

It is quite possible that items other than those indicated (or copies from other files), including some items which were NS, are in the 26 volumes. Nothing in these notes should be used without being checked.

- XI-27 One page is CE 2750, 10/31/59.
- XI-26 NS. I guess that this, or the other page of XI-24, is a copy of CE 917, 11/3/59.
- XI-25 3 pp. are CE 2749, 11/2/59.
- XI-24(2) 1 page is CE 918; other NS.
- XI-23 NS. (Wild guess: part or all of FBI report mentioned in XI-22)
- XI-22 Only 1 p. sent: SY TS for FBI report of 5/12/60 (CE 821).
- XI-21(4) P. 1: SY TS for FBI letter of 6/3/60. (See CE 834, # 14) P. 2 is copy of p. 1. Pp. 3,4: NS, but presumably this FBI letter. On the TS: "the final paragraph of the attached FBI memorandum indicates the possibility of an imposter using the Subject's birth certificate...."
- XI-20 NS.
- XI-19(2) P. 1 is SY TS for FBI letter of 2/27/61. (See CE 834, # 20) Dated 3/2/61. P. 2: NS, but presumably this FBI letter. TS requests that recipients (PPT,SOV,SCS,SCA) advise if the FBI is receiving information about Oswald on a continuing basis. 1 p. memo, 4/4/61, SY to PPT, repeating request made in XI-19. PPT reply to this request; basis for XI-16. (1 p., 4/19/61)
- XI-18 1 p. letter, SY to FBI, 5/25/61. (See CE 834, # 22)
- XI-17 PPT reply to this request; basis for XI-16. (1 p., 4/19/61)
- XI-16 1 p. letter, SY to FBI, 5/25/61. (See CE 834, # 22)
- XI-15(2) 2 copies of XI-17.
- XI-14(13) Pp. 1,2: FBI & SY TS's for pp. 3-13: FBI report of 7/3/61 (CE 822).
- XI-13 1 p., 9/12/61, apparently related to State Dept. name check on Marina. (See CE 834, # 26, and CE 2746.)
- XI-12(2) P. 1 is CE 989, 12/28/61. P. 2 is copy of p. 1.
- XI-11 NS.
- XI-10 5 pp. are CE 2686. Dated March-April 1962.
- XI-9 P. 2 is Navy to SY, 4/26/62, repeating request of 3/19/62 (CE 2686), and enclosing p. 3: typed copy of Oswald letter to Tompkins (19H695). Rest NS.
- XI-8,-7,-6 All NS. I guess these may include Seeley Ehd. 6, 5/4/62; the SY memo of 5/1/62 referred to there; and item # 36 of CE 834, 5/17/62.
- XI-5(17) Pp. 1,2: SY & FBI TS's for pp. 3-16: FBI report of 7/10/62 (CE 823). The last page was NS, but a copy is in the CE.
- XI-4(10) Pp. 1,2: SY & FBI TS's for pp. 3-10: FBI report of 8/30/62 (CE 824).
- XI-3(6) P. 1: INR TS. P. 2: FBI TS, dated 9/19/63. Pp. 3-6: NS, but presumably a copy of CE 829.
- XI-2 NS. My guess is the CIA 10/10/63 message. (See 24H510)
- XI-1(2) SY File Control Sheet, indicating file checked out 12 times (6/1/60 to 11/14/63). Names and dates given.
