Reur 4/11, when the statement is sent to Conyers et al, I hope you'll send me a copy. Thanks.


On the NRA letter, I do not know what Cakebread wrote them but from the picture there clearly are more than four grooves. As there were.



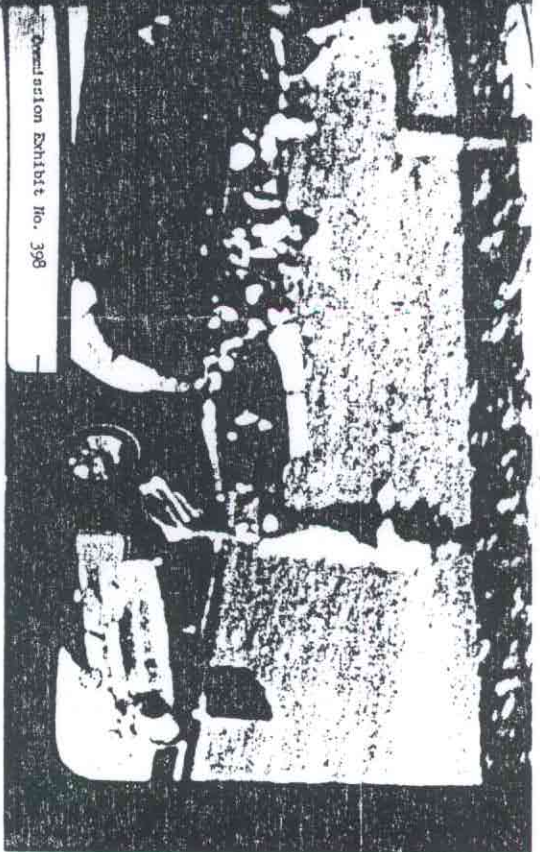

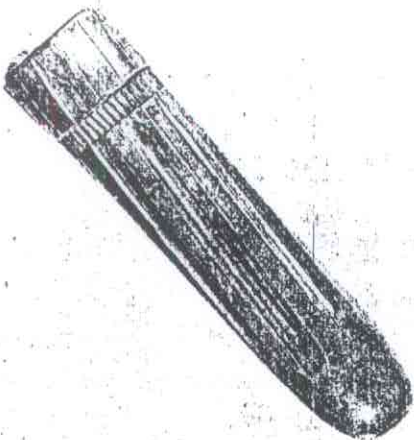
