Per Bureau instructions, enclosed for the Bureau are two copies each of the following three communications pertaining to organizations listed in referenced teletype:

1. Dallas airtel to the Bureau, 5/28/64, entitled, "LEE HARVEY OSWALD, aka; IS-R - CUBA" (Bufile 105-82555) (Dallas file 100-10461) (which enclosed listing of communications previously furnished the Bureau regarding organizations listed.)
2. Dallas County Sheriff's Office (DCS) report dated 11/23/63, prepared by Deputy Sheriff BUDDY WALTERS (deceased) (Returned to Dallas by the Bureau during 1964, as an exhibit for the Warren Commission).

3. Form letter, undated from "ALPHA 66" organization, 3126 Harpendale Street, Dallas, Texas, received by Dallas Office during November 1963, from a Mrs. DOROTHY KEASLER WEIN, 4141 Prescott Street, Dallas, Texas, (who received unsolicited form letter asking for donations from ALPHA 66.)

It is further noted, a review of Dallas airtel of 5/28/64 (with enclosed listing of communications re organizations such as FPCC, JURE, ALPHA 66 and 30TH OF NOVEMBER GROUP), reflects that all pertinent material was furnished the Bureau by this airtel of 5/28/64.

The following comments are being made regarding each of the above enclosures:

1. Dallas airtel to the Bureau, 5/28/64, entitled, "LEE HARVEY OSWALD, aka IS - R- CUBA" (Bufile 105-82555) (Dallas File 100-10461-6402). It is noted this 1964 communication to the Bureau, furnished the Bureau with nineteen enclosures pertaining to organizations such as "FAIR PLAY FOR CUBA COMMITTEE" (FPCC); "JUVENTUD REVOLUCIONARIA CUBANA" (JURE); "30TH OF NOVEMBER GROUP", and "ALPHA 66." Also enclosed with this 1964 Dallas airtel was a listing of communications previously furnished the Bureau during 1963, pertaining to the above-listed organizations, with Bureau file numbers shown.

2. DSO report dated 11/23/63, entitled, "DEATH OF PRESIDENT," prepared by Deputy Sheriff BUDDY WALTHERS (deceased), which report also states that WALTHERS was with Deputy Sheriff ALLEN SWEATT (also deceased), on 11/23/63, when he referred a matter to the U. S. Secret Service, Dallas, Texas, regarding an organization known to his source (not

further identified) as "Freedom For Cuba Party", which had been meeting at 3128 Harlendale Street, Dallas, Texas.

In connection with the above enclosure, it is noted from review of Dallas files that the above address referred to by Deputy Sheriff WALTHERS was erroneously listed as 3128, but the actual address was 3126 Harlendale Street.

Review of Dallas file reflects that the organization known as "ALPHA 66" held meetings during early 1963 at 3126 Harlendale Street, Dallas, Texas, and a letter furnished to the FBI Dallas by a Mrs. DOROTHY KEASLER KLEIN, 4141 Prescott Street, Dallas, Texas, reflects that she had received an unsolicited form letter from that organization on 11/19/63, asking for donations. The letter from "ALPHA 66" was on letterhead stationery, which reflected the above address and was signed by MANUEL RODRIGUEZ, General Secretary of "ALPHA 66."

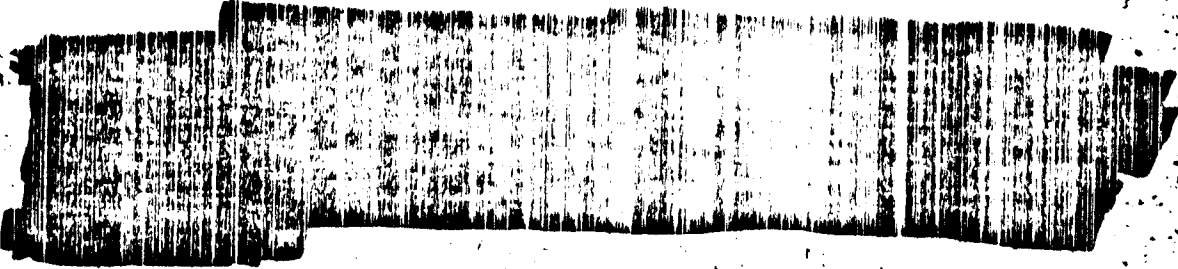
3. Above "ALPHA 66" form letter reflected that the "ALPHA 66" was an organization "United to Liberate Cuba."

A review of Dallas file [REDACTED] reflects that former [REDACTED] whose identity is known to the Bureau (Bufile [REDACTED]) [REDACTED]

According to this source, as well as other informants familiar with Cuban matters during the period 1963-1964, LEE HARVEY OSWALD was not known to have ever associated with, or been known to members of "ALPHA 66" and there is no information that he ever visited 3126 Harlendale Street, Dallas, Texas, as reported by Deputy Sheriff WALTHERS.

Dallas Office files contain no identifiable information regarding "Freedom For Cuba Party" or JORGE SALAZAR.



As will be noted in enclosure No. 1 above, the Bureau, during May, 1964, was furnished with numerous enclosures regarding above organizations, with individual communications listed along with Bureau file numbers that had previously been furnished the Bureau.

As to the above three items furnished as enclosures, it is felt by Dallas that the release of these communications will not jeopardize ongoing investigations, however, as indicated above, Dallas Division is not cognizant of the current status of former DL 282-S.

The DSO report of Deputy Sheriff BUDDY WALTHERS was never directly furnished to the Dallas Office by the DSO.
