After getting your letter I spoke to a prof who will seek a student. I doubt you'd want the clippings I also have but I mention them in the event you do.

Probably not many clippings on Roselli, some on Marcello and quite a few on Maheu but I think most of these clippings are about them and not about the activity in which you are interested.

I have a file of clippings on/plots against Castro if you want them. I understand that what you have in mind is the report given by Castro to some U.S. public figures, I think including George McGovern, on this.

These were plots detected by his security people.

I do have a name index to the Dallas ~~xxx~~ FBI office records that is an effective index to the FBIHQ records for the period that began with the crime and ended about a year and a half later. I suggest that the student use this bulky index and identify each record and then check to see if any is not among those of which I made separate copies for the subject file I explained to you.

If there are any she can then get those main files and make copies for you..

I can't be very helpful on Jack Ruby for several reasons, most important from your point of view and interests is that I never cast him in any such role. I also believe that for one person engaged in so large a study he was least likely to be a productive area for investing time. I have a subject file on him, I have the Dallas records on him, from which I made a selection for the subject file, even the letters written to him in jail, if I recall correctly. I also have the FBIHQ main file on his killing of Oswald. I don't think that copying all these files will be worth your time and cost but I do think that when names you are interested in appear in the Dallas index in Ruby files you ought get copies of them, if any.

Scads of clippings I don't think you'll want.

I don't know what you mean by an exclusivity contract but as I told you, I am interested for archival purposes and, after you have no objection, in giving a copy of the intercept(s) on me to the judge who was lied to about it in a FOIA case. I have no other interests, unless in reading them I spot something I can help you with. Come to think of it, I have some transcripts of intercepts on or about Willie Weisberg. I've forgotten the details but you are welcome to them if you want them. I'd be surprised if they are complete.



Following is a list of files we are interested in for our program AMERICAN EXPOSE: WHO MURDERED JFK?


