

Dear Jerry,

The list for which you asked is enclosed. Someone coming up from Arlington may get it in the mail sooner than if I send it from here Monday.

He is not due for a half hour. Another, a radio reporter, was due an hour ago. So, I've been doing the back filing I could and odds and ends. This list brought our conversation back to mind. If I had not wanted not to miss Reets I might have thought about it more.

My reference to Anson was not premeditated. However, with minimal reflection, it does appear that he can be of value to me in what I want to do and I can make possible for him what he has not been able to do, so we can have common interests. I have much more than "ew Times in mind.

For it to mean the maximum it would have to be as close to immediate as possible.

I could be talking about something with an open end. It depends. It might include a largely-drafted book of immediate topicality and enormous potential. Until we ~~talk~~ talk I cannot say. I would not without Jim's okay, which leads to an explanation that is required.

Once I realized that the ~~angels~~ ^{angels} on my should goof off once in a while and I can get sick and am not permanent I set up an estate. Jim has not formalized it simply because he has not had time. But I have it in writing, that he and Howard are to be the executors, with dated copies outside their possession to establish the fact and the date.
