MISCELLANEOUS INFORMATION CONCERNING

At 4:50 p.m. this date Assistant Director W. C. SULLIVAN of Division 5 advised that the Attorney General of the United States wants a documentation of the various charges that GARRISON has made since the inception of his investigation such as the conspiracy, the cross fire that CLAY was involved, that OSWALD met with CLAY, etc., and documented refutation of same based on the information contained in our files on the investigation. Mr. SULLIVAN asked how long it would take to do this and I advised him if we had all of the information in the Dallas reports we could probably do it in 3 weeks. Mr. SULLIVAN advised this had to be done in 3 days.

I advised Mr. SULLIVAN that I would confer with Mr. WALL and the other Agents who are familiar with the aspect of this matter, and after my conference I would recontact him by telephone as to what could be done.

MISCELLANEOUS INFORMATION CONCERNING

At 7:30 a.m., 5/30/67, I telephonically contacted the Bureau and talked to Section Chief WILLIAM BRANNIGAN and advised that any teletype in this matter would be at least 40 pages and told him unless I was advised to the contrary by him we would submit an airtel to the Bureau on 5/31/67, containing the information requested by Assistant Director SULLIVAN. He suggested this be mailed, and I pointed out to him this is Memorial Day and the Bureau would probably not receive it due to the lack of employees in the U.S. Post Office. He agreed we should have it hand delivered by pilot.

The 124 page airtel was prepared and given to the pilot of Delta Airlines. The Bureau was called at 3:30 p.m. and Supervisor TSCHIEET was advised of the flight number and the fact that the 15 copies of the airtel would arrive at Friendship Airport at 9:41p.m., 5/30/67, and he advised someone would pick it up.

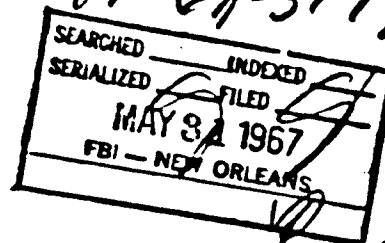
At 6:30 p.m., 5/29/67, I talked to TOM SMITH, Night Supervisor, Division 5, concerning the request of Assistant Director WILLIAM C. SULLIVAN, particularly that section in reference to the refutation of the allegations by GARRISON, pointing out we were not in a position of having all the facts to refute same unless we reviewed completely the Warren Commission Report, all of the files in the office and even then there might be files in the Office of Origin in which we would not have pertinent information.

Mr. SMITH recontacted the office and advised we did not have to do the refutation side of this, but should merely prepare a teletype to reach the Bureau by 12:00 noon, 5/31/67, containing all of the allegations of GARRISON and/or any of his staff.
