(W) (C) FPCC HAS CHAPTERS IN MOST MAJOR CITIES IN UNITED STATES. IN ADDITION, STUDENT COUNCIL CHAPTERS ESTABLISHED IN MANY COLLEGES AND UNIVERSITIES. AS OF APRIL 1961, FPCC MEMBERSHIP ALLEGEDLY. TOTALLED 7,000 IN 21 REGULAR AND 40 STUDENT COUNCIL CHAPTERS.

BEOADCASTING SYSTEM AS NEWS WRITER. TABER ALLEGEDLY FORCED TO
