On 19 and 20 October 1967, Source V-1 furnished information pertaining to SUBJECT to the undersigned. The initial contact on 19 October was by telephone at the undersigned's residence and the contact was initiated by the undersigned in person on 20 October 1967. Source furnished the following information in substance:

A friend of Source's, whom he identified as <u>Herbie Huber</u>, has 4800 caliber 30x30, lever action rifles. The rifles are dull finished, not blued, and are in crates each of which contains eight rifles. They are hidden at an undisclosed location in Texas. Huber was allegedly an Agent of the Central Intelligence Agency (CIA) at one time. He was to have delivered the weapons to unknown persons for use in the Bay of Pigs invasion; however, he could not make contact with the individuals so he, together with an unidentified associate, hid the weapons. The unidentified associate is allegedly deceased. luber originally had 6000 of the rifles. 1000 were allegedly delivered to inknown persons in Mexico. He has allegedly sold or otherwise disposed of 200 of them in the United States, details not known. Huber wants to get the reapons back in the hands of the government, but only for a price, since he eels that he was double crossed by the CIA. He has been in contact with arious representatives of the CIA who have expressed interest in buying the eapons from him; however, they have all acted in such a manner as to cause uber to believe they are only trying to trap him into revealing the location f the rifles so they can be recovered without paying him for them. Huber nd Source have been friends for a long time. On an undisclosed date Huber oproached Source to act as intermediary in the sale of the weapons. On an known date, Source and Huber traveled to Houston, Texas, to meet a man legedly from CIA. They were to meet at a motel that Source could not member the name of, during the afternoon. Source and Huber were delayed by d weather and did not arrive at the meeting place until 2100 hours and when ey located the man he was drunk. On another occasion they were approached representatives of Inter Armco Limited, a firm in Alexandria, Virginia, o were interested in buying the rifles. They were invited to Alexandria discuss the sale. They paid their own air fare to Washington, D. C., where e representatives had made arrangements for their accomodations in a hotel. e representatives wanted a Certificate of Title for the rifles which Huber ild not supply. Source and Huber have allegedly been approached by persons porting to be from Argentina and also from Bolivia who have expressed an erest in buying the rifles. A Cuban refugee identified as Dr. Ferrara, fnu, also approached them to buy the rifles. Ferrara was staying at the tainebleau Motel, Tulane Avenue, New Orleans, Louisiana, at the time he te the approach. Source did not explain fully the reasons for Huber not ing sold the rifles to any of the above mentioned individuals except to that they prefer to have them returned to custody of the U.S. Government. The stated that he will be happy to meet with any representative of the U.S. ernment anvtime, anywhere, as intermediary for Huber. Source also stated ly C. Duckworth, 112th MI Group. 6. Source and Huber couldined a man by the name of Chyde Hyde who operates a adgitepot known as file Cay 90's in Shreveport, Louisiana, who could allegadly assist them is disposing of the rifles to the US Government. Hyde contacted the Federal Bureau of Investigation (FBI) and the CIA attempting to sell the weapons to either agency without success. Recently, date not specified, Hyde contacted Source and said he had a buyer for all of the rifles but they would have to be delivered to a Guif Coast port. The specific port was not cettled upon but Bromsville, Texas, was one of those mantioned. Huber is straid to make such a deal because he now believes Hyde wants to trop him for United States Customs officials who would the a pey Hyde wants to trop him for United States

contraband. Source's purpose in contacting the undersignal was to rehim to determine whether or not the CIA or any other branch of the US Government is genuinely interested in buying the rilles from Nuber and when and where orrangements can be made for the purchase. Source stated that they have mat with a number of people who alleged themselves to be in a position of authority and who could make decisions repording the purchase but who were unable to do so.
