Dear Mr. Melody,

Please excuse my delay in answering your letter of 6/24. It was lost at the bottom of a pile on my desk.

If my opinion means anything to you, I encourage you in your choice of study. We do not lack for political writers or "plottical" writers, but we do lack so potent and honest ones.

When you can, will you please amplify your remarks about George de Mohrenschildt? Our reference to my third volume is an error. It deals with the suppressed photographic evidence and its suppression (flyer enclosed).

The problem of obtaining my books is universal. The pressure is against bookstores handling them and most journals, including those of the left, boycott them. However, many libraries buy them direct from us and they are available through some of the major wholesalers, including Raymar Book Co., Monrovia, Calif.

I will be glad to send you the second volume and any others you desire once you have authorization. The price is \$5.00. You can pay whatever you can afford. If you can afford nothing, do not feel obligated. We'll send it and the others that are coming anyway. The first two volumes are now available in Dell reprints but the third will not be. My coming book on the New Orleans aspect will be available (text only, no appendix) from Parallax Publishing Co. in reprint size and price range.

Dear Mr. Dickerson:

Reference is made to my telephone interview with your office on November 9, 1966, at which time I had notified you ( personally ) that after having consulted with an official representing the Consulate General of Switzerland in Chicago — regarding the general problem I was having with the Government agency to which you belong — I was preparing to flee the United States via Guatemala.

As you know, upon my return to Chicago ( from a federal penitentiary ), one of the first things I had done was to take out an Annual Basic Membership to the Illinois Division of the American Civil Liberties Union ( at Chicago ) — well-knowing that because of Secret Service visits to the U. S. Penitentiary at Leavenworth, Kansas, I could certainly expect more "visits" from the aforementioned agency on the outside; although I really didn't believe THEN that your office could succeed ( through continual harassment ) in forcing an individual to resign from a job on a month-to-month basis.

At any rate, the purpose of this particular letter at this time is to inform you that Mr. M. S. Arnoni, Editor — and a personal friend — of the MINORITY OF ONE publication, ( P.O. Box 544, Passaic, New Jersey ), the same of whom is now acting on my behalf, will request your Washington office for the complete file on my case; and he shall pose some very definitive questions with regard to First Amendment guarantees provided for in our Bill of Rights.

I have no fault, nor any argument with Mr. Homer Heagley of the federal Probation & Parole office at Chicago — as he treated me most fairly. But he himself was aware that your office was "officially" interested in my return to Chicago on August 11, 1966.

Moreover, Mr. Heagley was also aware of the fact that your office was the ONLY reason which had kept me from complying with ALL of the general rules contained in what is known as a "Conditional Release" ( "C - R" in penal jargon ) from prison. And within a short period of time, an official associated with the Lawyers Division of the American Civil Liberties Union at Chicago will interview Mr. Heagley with regard to the file that the U. S. Board of Parole has compiled on the matter of "revoking" the aforesaid "C - R" release from penal servitude.

Meanwhile, for the record, Mr. Dickerson, I should like to reiterate what I had stated to you on November 9 of the closing year: If the United States Secret Service has anything to say against my mimeo leaflets and letters, et al media, ( re my political interpretation of U. S. Foreign Policy in Vietnam ), or has any criticism regarding the extreme Leftist SLANT contained therein, I suggest that the Secret Service state their criticism — FORMALLY — in a Court of law.

May I have an early reply to the foregoing? Thank you ~~now~~ so much.
