Besides that, Jim filed a suit for Chip Selby and me in which I got the right to duplicate each individual frame from the original. At that time Groden had promised to do that. He then backed out. That is why I asked for the right and that is why I could not exercise it when I got it.

Please tell Jim thanks for the belated forwarding of my letter to Linda Hunt.

I'm glad also that he was rushed and just sent me a xerox of his letter to her to give me her address. I think I can help her with Peron and I so wrote her immediately.

I was for a while a Latin Americanist in intelligence during and for a short while after World War II.

Then I got a very nice letter from her yesterday, before she got that letter.
