Dear AARC Friend or Member:

I am pleased to enclose a copy of the first issue of the <u>AARC</u> <u>Quarterly</u>. I hope that you will approve of the job we have done, and will look forward to receiving the next issue.

Because of the AARC's beleaguered financial state, putting out this newsletter has taken a great deal of time and effort by a few dedicated people. If you want AARC to continue to do this job, we need your support.

For the past decade the AARC's annual dues have remained constant at \$25. Now we find it necessary to raise dues to \$30 per year. However, we are also committing to publish a quarterly newsletter of high quality. We are also offering multiple year membership at a discount. Members paying dues for three years or longer will become members at the rate of \$25 a year or less. The new rate for membership dues, effective June 1, 1995, is:

1 year: \$ 30.00 3 years: 75.00 5 years: 100.00

The <u>AARC Quarterly</u> is received at no additional charge by members. Back issues are available at \$4.00 each for single copies of an issue, \$ 10.00 for three copies of an issue, and \$30.00 for 10 copies of an issue.

Finally, some news that came too late for inclusion in the newsletter. On May 3rd, the Assassination Records Review voted to adopt a revised definition of "assassination record." Listening to criticism by the AARC and others, the Board deleted the phrase "may have led to" in § 1400.1 of its proposed regulations, and replaced it with "reasonably related to." It also included "persons" within the basic definition, as I had suggested. It has also scheduled a hearing to be held in New Orleans, tentatively set for June 28th.

- The Paines The FBI has released approximately 1900 pages on Ruth Paine and 1700 pages pages on Michael Paine. Very little material has been withheld from these files.
- <u>DeMohrenshildt</u> The FBI has released approximately 2,000 pages on Georges DeMohrenschildt. Only a small percentage of material has been withheld.
- <u>Clay Shaw Trial Transcript</u> The AARC has obtained the complete Clay Shaw trial transcript, consisting of approximately 3,500 pages. A breakdown according to the individual witnesses who testified is available upon request.
- Oswald Marine Corps File Lee Harvey Oswald's official Marine Corps file. 364 pages. \$ 40.00 (postage included)
- JFK Review Board Transcripts The AARC has obtained copies of the transcripts of all of hearings held by the JFK Review Board to date. They are available to members at our usual rate of ten cents a page. The October 11, 1994 hearing featured testi-mony by AARC President Jim Lesar and others (Page Miller, John Newman, Peter Dale Scott, Mark Zaid and others). The purpose of the hearing was to elicit views on the definition of the term "assassination record").

The AARC also has the written statements submitted by the persons testified at the Review Board's October 11 hearing. These statements generally contain much more information than their actual testimony.

- Ebersole Interview--The AARC has obtained the transcript of Dr. John Ebersole's appearance before the HSCA Medical Panel on March 11, 1978 (69 pp.) We expect to soon have the transcript of Dr. Pierre Finck's testimony before that panel (61 pages). A copy of Finck's testimony at the Clay Shaw trial is available (286 pages).
- Code Name "Solo" Packet--On March 30, 1994, the FBI released a packet of materials on the "Code Name 'Solo" informants (Jack and Morris Childs) who reported to the FBI on Communist Party leaders at home and abroad. The packet includes only their reports pertaining to Kennedy assassination matters. In the packet is a copy of CD 1359, which was actually released by NARA at the end of January, 1995. With identification forms, the packet contains 293 pages.
- Sam Giancana Files--The AARC has obtained the entire release of FBI files on Sam Giancana and Gus Alex, consisting of about 10,000 pages.
- Robert J. Groden v. Random House, Inc., The New York Times Company, Inc., The New York Times Sales, Inc., and Gerald Posner. The brief for Appellant Robert Groden. in Groden's Lanham Act lawsuit against Gerald Posner, The Times. and Random House. \$ 10.50 (postage included).
- Appendix to Appeal Brief in Groden v. Posner. Comprised of the papers filed in U.S. District Court, including the affidavits of Dr. Randolph Robertson, Dr. Cyril Wecht and Harold Weisberg, as well as the complaint, amended complaint, and the District Court's Memorandum Opinion ruling in favor of Posner and company. 417 pp. \$47.00 (postage included).
- Case File in D. Mark Katz v. National Archives and Records Administration. This is a Freedom of Information Act lawsuit brought by Mark Katz to obtain access to the Kennedy assassination autopsy x-rays and photographs. Includes briefs, two opinions by the District Court, and affidavits by Dr. Cyril Wecht, Dr. Randolph Robertson, Dr. David Mantik, Dr. Louis P. Kartsonis, Harry Livingstone, Mary Ronan, Burke Marshall and Mark A. Crouch. 269 pp. \$ 32.00 (postage included).
