Anson, Robert Sam. <u>They've Killed the President</u>, Bantam Books, New York, 1975. Although not real thorough, a good overview of other people's research by this <u>New Times</u> editor. Unnecessarily critical of Garrison.

Cutler, Robert B. <u>Crossfire: Evidence of Conspiracy</u>, Mirror Press, 1975. Contains diagrams, charts, and revisionist theories on bullet flightpaths in Dealy Plaza. (Available from author at 38 Union St., Manchester, Ma. 01944).

Epstein, Edward J. <u>Inquest: The Warren Commission and the</u> <u>Establishment of Truth</u>, New York, Viking Press, 1966. A study of the workings of the commission. Although he later lambasted Garrison, here the author obtained quotes from commission counsels on the inadequacy of the investigation.

Garrison. Jim. <u>Heritage of Stone</u>, New York, Putnam, 1970. Best book on the overview, with choice excerpts from his investigation.

Jones, Penn. Forgive My Grief, vol. I-IV. Re-prints of numerous columns from The Midlothian Mirror and Mr. Jones' 12-year research. Particularly good on key witnesses and their often mysterious deaths. (Available from author, Box 1140, Midlothian, Texas, 76065).

Lane, Mark. <u>Rush to Judgement</u>, New York; Holt, Rinehart and Winston, 1966. A best-seller which contains fine original work. Now available in paperback.

MacFarlane, Ian. <u>Proof of Conspiracy</u>, Australia, 1975. An excellent collection of photographs, a good summary of the evidence and an anthology of collected writings. (Obtainable through AIB--\$6.00).

Meagher, Sylvia. <u>Accessories After the Fact</u>, Indianapolis; Bobbs Merrill, 1967. The most comprhensive, scholarly treatment of the Warren Commission's failures. <u>Has become the classic text</u>. Coming out in paperback.

O'Toole, George. <u>The Assassination Tapes</u>, New York, Penthouse Press, 1975. A recently developed piece of technological wizardary, the Psychological Stress Evaluator, finds Oswald innocent. Also contains a good summary of key evidence.

Popkin, Richard. <u>The Second Oswald</u>, Avon Books, 1966. The thesis that someone impersonated Oswald in the effort to frame him is convincingly presented. Out of print. Try used book stores and libraries.

Roffman, Howard. <u>Presumed Guilty</u>, Farleigh Dickinson U. Press, 1975. A thorough and well-documented presentation of Oswald's innocence in the shooting. Order by mail from Farleigh Dickinson U. Press.

A collection of previously published articles on the JFK, MLK, RFK, and Wallace shootings by such diverse authors as Turner, Belin, Wecht E.H. Hunt, Meagher, Rockefeller Commission, Thompson, Weisberg, and Vidal. A concise, excellent collection.

Thompson, Josiah. <u>Six Seconds in Dallas</u>, New York, Bernard Geis Ass., 1967. An examination of bullet angles, medical and ballistic evidence, and photographic material, including the Zapruder, Nix, and Hughes films. An important book, unfortunately out of print. Try used book stores and libraries.

<u>Meisberg</u>, Harold. <u>Whitewash I-IV</u>. Extensive and meticulous research by the most prolific writer in the field. **Last**evolume contains the previously top-secret Jan. 27, 1964 WC transcript. (Available from author, Route 8, Fredrick, Md. 21701).

eissman, steve (ed.). <u>Big Brother and the Holding co.--world Behind</u> <u>Matergate</u>, Ramparts Press, 1974. An anthology of writings on assassinations, organized crime, covert intelligence operations, etc. Some excellent writings.

Yazijian, Harvey of the AIB and Blumenthal, Sid (eds.). Government by Gunplay, New American Library, 1976. Excellent survey of basic arguments for conspiracy in the JFK, MLK, RFK, and Wallace shootings, plus vital background articles on Watergate and organized crime. Contributors include Bill Turner, Carl Oglesby, Phillip Agee, Peter Dale Scott, and Allard Lowenstein.
