The assassination of John F. Kennedy brought sudden, unaccustomed attention to a few individuals who found themselves by accident on the periphery of a national tragedy. Here is how some of them have fared in the years since.



W. Kemp Clark . . . Chief of neurosurgery at Parkland Memorial Hospital . . . Pronounced the President dead at 1 P.M. Central Standard Time, Nov. 22, 1963 . . . Now professor of neurosurgery and chairman of the neurosurgery department at the University of Texas Health Science Center in Dallas.

Marina Pruskova Oswald . . . Russian-born wife of Lee Harvey Oswald and mother of his two children . . . Received donations after Oswald's death totalling more than \$70,000 . . . Married Kenneth Jess Porter, a tavern operator, in 1965 . . . Sued the Government for \$500,000 over confiscation of Oswald's property and was awarded \$17,729 this year . . . Resides with family in Rockwall, northeast of Dallas.
