I had appeamnes in the Bay area, LA, then San Diego, then back in $L A$, and then - left for N.O. Whence I wot to Dallas, then returned to S.O., then came hone.

Not being able to think of any reason I would have wanted to go out there in mid -1968 and knowinewhat 2 wanted to do elsewhere, there must have been sone suggestion to ne that the 'LA MJ for sone reason wanted mex there and in response I explained what was the fact, that I did not and could not travel unless 1 was making a. paid appearance.

As I've been reminded of this in the past and thought about it the only thing I could recall for which I wanted to return to Calif. did not cone up until ny last trip out there, in October and November, 1968, which is sone months after the tine I heard from the LAFD about the Jones Harris fabrication I'ra sure I've explained to you. It was on that trip that I met Joan Kiftchoock. Shend wine been one of JKK's Lady friends and I was her guest when I was in SF that trip. We spent much tine taking about her relationship With JEK and decided that when I returned wed do an oral history sherd out in a safe box for the future. (She' is since died.) I don t recall what notes I made, if any, but - do have a picture of her and Paul Hooch I took outside her mansion homo which, as I now recall, was on Metropolitan "venue.

So, in retrospect, I suspect that the LAPD was interested in creating records that it could use to make the critics look bad. I cant think of any other reason. But if you see any more on that matter Ind be interested.
