Kennedy assassination and critics of the Warren Commission's Report have lost a number of fellow researchers in the past twelve months, as well as four people we would have enjoyed spending an evening interrogating—hopefully receiving truthful responses.

Jeanne deMohrenschildt, widow of George deMohrenschildt who was the Russian-born "best friend" of Lee Harvey Oswald, died January 21, 1993, in Woodland Hills, California. Many of the researchers knew Jeanne and had enjoyed her gracious hospitality and gourmet cooking. Those of us who knew her best never felt she was entirely candid.

Carlos Marcello died in February 1993 in New Orleans. He was the reputed head of the Southern and Southwestern Mafia.

John Quigley, FBI Special Agent who interviewed Oswald in the New Orleans jail in August 1963, died in West Palm Beach, Florida, on August 24, 1994.

Seth Kantor, author of *Who Was Jack Ruby?* died in September 1993 in Bethesda, Maryland. Seth was a fine jour-

nalist and always a gentleman. We shall all continue to miss Seth's wise council.

Frank Sturgis, Watergate burgler and alleged "tramp" went into the hospital following a short illness. He died of cancer one week later on December 4, 1993.

Sue Robinson of DeFuniak Springs, Florida died December 19, 1993, in DeFuniak Springs, at age 48. She was researcher who helped numerous authors through the years. Pete Brewton acknowledged Sue's help in his book, *The Mafia, CIA, and George Bush*, and Peter Dale Scott thanked her for her help in *Deep Politics*.

Michael H. B. Eddowes, the London Solicitor who had Oswald's body exhumed on October 4, 1981, died in London, Tuesday morning, December 27, 1993.

The death that will affect more Kennedy researchers than any other this year was **Larry Howard's** death in the early morning Saturday, January 8, 1994. Larry was one of the founders and President of the JFK Assassination Information Center in Dallas.
