Re CMK's 4/15, I think it is possible the FOIA agents who drafted this letter are playing games with words. I suggest you wrote farthur.

"...the FBI does not possess automsy records for the automsy of " JFK.

Get around that play on words and ask them how they could have conducted the investigations assigned to them without such knowledge because:

This is the most basic evidence in a homicide;

The President directed an FBI investigation immediately, as Director Hoover testified;

While this was before he appointed the Warren Commission, the FBI was in the same role for that Commission;

And existing records of the FBI establish the existence of records they have not provided you.

If you want you can ask if they have had the Baltimore Field Office searched.

There has to be more there than the single set of Sibert-O'Neill reports I use in Post Mortem.

There is a similar pattern in the King case. ere I'm obtaining all the FBI HQ files, with maskings. The Memphis Field Office did obtain and did not send to Washington similar information.

There was a similar physical situation revolving around the shooting and a similar political situation - Hoover wanting to keep control, a la Orwell.

This way the FBI can always deny, using HQ files for denial, and always produce, using FO files to produce.

I think it would be worth persevering on how they investigated the crime without knowing the basic evidence relating to it.

Hastily,

after Kelley & Ginney assured me they had nothing re my request me autopsy, I wrote them that on the basis I what is public this can't be true (you have that letter). So, with This letter CMK sent me FBI cysies of what I cited to him-all published before-incl in PMI. The copies are clearer & have some lines drawn in margins. also, they are stamped with same page #'s as in the CD's - I presume that is how the WC received them.

As I stated in my letter to you dated February 24, 1977, the FBI does not possess autopsy records for the autopsy of John F. I now reiterate that suggestion since they may possess the information concerning the chain of custody of those records.
