AT TWELVE FIFTY PM, TODAY, HUGH AINSWORTH, FORMER DALLAS, TEXAS,
NEWSPAPER REPORTER, TELEPHONED AN SA OF DALLAS OFFICE FROM HOUSTON,
TEXAS, WHERE HE STATED HE IS EMPLOYED CURRENTLY BY NEWSWEEK MAGAZINE,
ROOM NINE ZERO THREE, HOUSTON CHRONICLE BUILDING, TELEPHONE CAPITOL
EIGHT-EIGHT SEVEN EIGHT ONE.

AINS WORTH STATED HE HAS CONSIDERABLE INFORMATION HE WOULD LIKE
TO FURNISH TO AN FBI AGENT IN ORDER TO "HAVE ON RECORD" FACTS OF
ALLEGED INTIMIDATION, BRIBERY, COERCION, OF PERSONS WHOM NEW ORLEANS
DISTRICT ATTORNEY GARRISON IS ATTEMPTING TO HAVE TESTIFY. HE
SPECIFICALLY MENTIONED NAME OF ALVIN BEAUBOUF, ALLEGED FRIEND OF
FERRIE, DECEASED, WHO HAS BEEN OFFERED BRIBE AND LATER INTIMIDATED IN
CONNECTION WITH GARRISON'S EFFORTS TO HAVE THIS PERSON TESTIFY
FALSELY. AINSWORTH STATED THERE WERE OTHERS AND HE FEELS THE LIVES OF

THESE PERSONS ARE IN SERIOUS JEOPARDY. HE STATED SOME OF THE INFORMATION HAS ALLEGEDLY BEEN FURNISHED TO REPRESENTATIVE WILLIS, HOUSE ON UNAMERICAN ACTIVITIES COMMITTEE.

AINSWORTH STATED HE REALIZED NOTHING WOULD LIKELY PLEASE GARRISON MORE THAN TO HAVE SOME FEDERAL AGENCY INTERVENE OR CONDUCT INVESTIGATION WHICH WOULD PERMIT HIM TO "GET OFF THE HOOK" BY CLAIMING HIS EFFORTS HAVE BEEN THWARTED BY THE FEDERAL GOVERNMENT. AINSWORTH STATED IT IS HIS BELIEF THE CIVIL RIGHTS OF PERSONS ARE BEING VIOLATED BY GARRISON, ET AL, AND WOULD LIKE TO FURNISH INFO TO BUREAU REPRESENTATIVE IN PERSON.

IN VIEW OF AINSWORTH'S DESIRE TO COOPERATE AND HIS POSITION THAT CIVIL RIGHTS OF PERSONS ARE BEING VIOLATED, IT IS RECOMMENDED THAT THE HOUSTON OFFICE BE INSTRUCTED TO CALL AINSWORTH AND INFORM HIM THAT WE WILL BE GLAD TO VOLUNTARILY ACCEPT ANY INFORMATION HE DESIRES TO GIVE. IT IS NOTED HE STATED THIS INFORMATION IS TOO LENGTHY TO BE REDUCED BY HIM TO LETTER FORM.

PURSUANT TO MY TELEPHONE CALL TO BUREAU, SAC WHALEY OF HOUSTON IS BEING INSTRUCTED TO CALL AINSWORTH AND TELL HIM THAT IN CONNECTION WITH HIS REQUEST, IF HE WOULD LIKE TO COME TO THE OFFICE AND VOLUNTARILY FURNISH INFORMATION, WE WILL CERTAINLY BE GLAD TO TAKE THE SAME.
