Dear Mr. Hoover:

In my several weeks of investigation in New Orleans on Jim Garrison's assassination conspiracy hoax, I have encountered one thing time and time again that hurts the defendant, Clay Shaw, who, you know, is guilty of nothing near charged.

People ask, "Why did the F.B.I. investigate Shaw if he wasn't guilty of something?"

Since the Bureau de-classified additional documents to show Dave Ferrie's role--or lack of role, perhaps I should say--in the assassination investigation, why couldn't it also release those pertaining to the investigation of Clay Shaw?

This, I think, would be only fair. It would help an unfairly accused defendant and I hardly can fathom how it could harm innocent individuals, for all those who can be harmed have already felt the sting of Garrison's unusual "investigation."

I have collected additional data pertaining to Garrison's unorthodox use of the law and will relay it to your representatives as soon as possible.

But in the meantime, couldn't somebody see and report about the F.B.I. "file" on Clay Shaw? I'm not asking for any favors. I would expect it to be released to any responsible newsman or news media, not to me or to NEWSWEEK.
