assignments in connection with the assassination during this period and received some assistance from other Agents in connection with their photographic assignment.

In view of the public appeals for pictures and the notices sent to developing companies, SAs BARRETT and LEE 👾 🚉 🚓 handled a very large number of leads to check and review photographs and film possibly pertinent to the investigation. It was a general practice, insofar as SA BARRETT's recollection is concerned, to pick up such pictures or film on a loan basis and examine any still pictures at the time of obtaining them, but to return any movie film to the Dallas Office where projectors and viewers were available for examination. Receipts were normally given the individuals making such material available if the material was removed from their . possession. Due to the exigencies of the situation during 4 the early stages of the investigation, movie film was not entered as an exhibit until it had been reviewed and a بريابية المنافقة على المنافقة المنافقة المنافقة المنافقة determination reached as to whether it was of value and should be retained as possible evidence or of no value and should be returned to the individual making it available. If such film was returned, the receipt previously given for it was normally picked up and entered as a 1-A Exhibit.

SA BARRETT advised that he recalls FRED BRUNER as an attorney in Dallas, Texas, with whom he came in contact during his assignment to the Dallas Office, but that he has no recollection of any contact with BRUNER in connection with any film connected with the Dallas assassination. SA BARRETT advised that the contacts alleged by BRUNER to the Dallas Office are entirely possible although he has no recollection of them at this time. SA BARRETT advised that he does not recall PATSY/PASCHALL, also known as Mrs. CLYDE W. PASCHALL, JR., and has no recollection of ever having heard of or been in contact with this person.

SA BARRETT advised that he does recall going to the Dynacolor Corporation on Halifax Street in Dallas, Texis, a photographic processing company, to pick up some film in connection with the assassination, which he believes was movie film and may well have been the film referred to by BRUNER although SA BARRETT has no specific recollection of the exact content of the film picked up

at Dynacolor. SA BARRETT advised that all movie film; including this, was reviewed as quickly as possible, generally the same day. He recalls reviewing movie film taken in Dealy Plaza, which was determined to be of no value because it contains a sequence of pictures of SA BAPRETT crossing Houston Street in Dealy Plaza and SA BARRETT did not arrive at that location until, about 1:00 p.m. on 11-22-63. SA BARRETT considers? that in view of BRUNER's comments that this must have been the film picked up at Dynacolor Corporation. This film was then returned either to Dynacolor Corporation, to the owner of the film, or to an agent of the owner, although SA BARRETT has no specific recollection of to whom the film was returned or whether the film was returned by him or another Agent. SA BARRETT stated that he did not believe this film was retained as long ! . . as three weeks as all film of no value was normally.... returned within about one week at the most. However, during this early stage of the investigation, film of no value could have been retained longer than it would have normally. SA BARRETT has no recollection as to : whether the return of a receipt originally given for this film was obtained at the time the film was returned or not.

SA BARRETT advised that no copies were made or caused to be made by SA BARRETT of any private movie film obtained during the investigation except for the; "ZAPRUDER" film, of which copies were obtained and forwarded to the Bureau on 11-24-63 at the instructions of the SAC, Dallas. Copies of commercial film and television tape in connection with the OSWALD killing were also obtained by SA BARRETT. Specifically, SA BARRETT advised that the movie film picked up for examination by him at the Dynacolor Corporation and the movie film which contained a sequence of SA BARRETT grossing the street at Dealy Plaza was not copied while In the possession of the FBI to the best of SA BARRETT's knowledge, and, as previously mentioned, there would have been no purpose served insofar as the FBI's investigation was concerned in copying this film. BARRETT also stated that this film would be valueless to him as a personal souvenir as it only shows the back. of his head in the middle of a crowd of people crossing his street. And the second

discussions with Mr. BRUNER, it is pointed out that apparently the first thing "Life" magazine did in examining this film as a possible purchaser was to determine whether or not the film furnished was an original. This would appear to be the first logical step by any prospective purchaser in the publishing or news media fields. Mr. BRUNER indicated that negotiations have previously been had with other prospective purchasers of this film, specifically magazine publishers, and that the film was out of his possession for examination by them. It appears highly probable that had the film examined by these previous prospective purchasers been anything other than an original, this fact would have been called to BRUNER's attention by one or more of them.

Birmingham, Alabama October 18, 1967

I, Robert M. Barrett, am employed as a Special Agent of the Federal Bureau of Investigation and have been so employed since April 14, 1952.

On October 17, 1967, I was advised by Special Agent in Charge George W. Hall that Mr. Fred Bruner, an attorney in Dallas, Texas, contacted the Dallas Office of the FBI on October 16, 1967. Mr. Bruner stated that he represents a Mrs. Patsy Paschall who, on November 22, 1963, took some colored movie film of the Presidential Parade, including some film in Dealy Plaza in Dallas subsequent to the assassination. Mr. Bruner stated that based upon information from the Dynacolor Corporation, Halifax Street, Dallas, Texas, that the FBI should be called in connection with this film, he called the FBI Office in Dallas and talked to someone, possibly Special Agent Robert M. Barrett, which resulted in Special Agent Barrett coming to the Dynacolor Corporation and picking we this film for investigative purposes, giving Mr. Bouner a receipt. Mr. Bruner also advised that SA Barrett meturned this film, according to his recollection, some three weeks later, stating it was of no value to the investigation and pointing out that one of the films had a picture of SA Barrett himself in Dealy Plaza and he did not arrive there until after the assassination.

Mr. Bruner stated that he and Mrs. Paschall had been negotiating with various people to try to sell this film and he recently delivered the film to a representative of "Life" magazine, who took the film to New York to look it over. He stated the film may have been out of his possession on other occasions in connection with sales negotiations. He stated that on October 16, 1967, he received a telephone call from "Life" magazine stating that the film he had given them was a duplicate and not the original. He stated that Mrs. Paschall had advised him that she had not had a copy of the film made. He inquired as to whether the FBI might have made a copy of this film and inadvertently returned the copy to him instead of the original.

I have known Fred Bruner as a practicing criminal attorney in Dallas for approximately ten years, and I have had numerous contacts with Mr. Bruner both officially and socially during the time I was assigned to the Dallas, Texas, office of the FBI. I do not recall ever having any contact with anyone by the name of Patsy Paschall. I do not have any recollection of having any contact or conversations with Mr. Bruner in connection with any film which was connected with the investigation of the assassination of John Fitzgerald Kennedy in any way although the contact, as stated by Mr. Bruner above, is entirely possible. I do recall in

connection with my investigation in this case going to Dynacolor Corporation, Dallas, to pick up a movie film which might possibly be of value in the investigation. I also recall reviewing a movie film which depicts a scene in Dealy Plaza some 30 minutes after the assassination. I am sure of this time because this film depicts myself, in one sequence, from the rear crossing Houston Street, and I arrived at this particular area at about 1:00 p.m., Movember 22, 1963. I cannot definitely state whether the film I reviewed containing this sequence is the film I picked up at Dynacolor, but this is entirely possible. I cannot state how long this film was kept in the possession of the FBI, Dallas, but it was normal procedure to return valueless film to the donor as soon as possible after such a determination was made. I do recall that in all instances where film was released to me personally, I would furnish the donor a receipt for same and in most instances when the film was returned this receipt was picked up. Although I have no specific recollection concerning the return of this particular film, I am positive that it was returned because it was valueless to the investigation.

I wish to state that I had no copy made of the film which depicts myself crossing Houston Street. I have no knowledge of any copy of this film ever being made.

The film which contained a sequence showing me in the

Dealy Plaza area was the same film which was subsequently
