"Mr. Hugo Winterrowd Agent in Charge F.B.I. Federal Bldg., No. Main Memphis, Tennessee

"Dear Sir:

"I, Douglas Lanier, in the Shelby County Jail, wish to see an agent from your office in regards to rights violations and possibly worse since more than one state is involved, as I see it. It is a matter for the Federal Government now.

DOUGLAS LANIER was contacted at the Shelby County Sheriff's Office Jail, Hemphis, Tennessee, and furnished the following signed statement:

"Memphis, Tenn. Oct. 26, 1965

A SHARWARD OF THE

"I, Douglas Lanier, make the following voluntary statement to Ralph J. Liewer and Andrew M. Polumbo who have identified themselves to me as Special Agents of the FBI, U. S. Department of Justice. Mr. Liewer has advised me that this statement may be used in a court of law.

"I am twenty-six years of age and have earned a high school diploma. I am presently being held in the Shelby County jail, Memphis, Tenn. on a charge of grand larceny. My home prior to coming to Memphis was Baton Rouge, Louisiana.

"I have requested an agent of the FBI to contact me se that I might supply him with the following which I believe indicates a violation of my constitutional and civil rights.

The first item of which I complain is illegal arrest in that I was arrested in Baton Rouge Ia. by Deputy Bonnano of the East Bton Rouge Parish Sherrifs department. This was at 8:50 P.M. on May 2, 1965 and by his own admission Deputy Bonnano knew of no warrant outstanding for me at that time. This admission was made in Shelby Co. Criminal Court, Division 3 on Oct. 20, 1965 by Deputy Bonnano. This was in Memphis, Tens.

"The second item is that I was held from May 2, 1965 to June 10, 1965 in the East Baton Rouge Ia. Parish jail without being formally charged with any crime or without appearing before any magistrate or without any hearing of any kind. On several accessions I tried to make bond but was teld making bond would be useless because I was being held as a fugitive wanted by various departments. When the Arkansas hold was dropped I was teld I was being held as a fugitive from Memphis.

Detective Bonana took from me satements which he later used against me in court. At no time did he advise me of my right not to make a statement and later he admitted this in Shelby Co. Criminal Court, Division 3, Memphis Tenn. on Oct. 20, 1965.

"The fourth item of which I complain is that during my above-mentioned stay in jail my automobile was illegally searched by detective Bonnano and others. Neither my wife nor I had given permission to search my car. Evidence was obtained from this search which evidence served as the basis for the charges presently pending against me. Bonnano has stated in Oct. 20, 1965 in Div.

3, Shelby Co. Criminal Court, Memphis, Tenn. that he did search my car and did not have a warrant.

extradition papers while I was in jail in East Baton Rouge, Ia. This was done on June 8, 1965 by telling me that if I agreed to waive extradition, charges in Louisiana would be dropped. On the basis of this waiver I was extradited to Memphis Tenn. although no warrant was read to me in Louisiana or explanation made as to why I was being extradited. After I arrived in Memphis, Tenn. I was held 19 hours for investigation. I believe it illegal to extradite only to be held for investigation. During the above mentioned 19 hours I tried twice to make a telephone call and was denied the privilege by the jailer in Memphis city jail.

"The sixth item is that the warrant eventually read to me was defective because the date it was sworn out was the 23rd of April, 1965 and I was not even known to those people on the 23rd of April. The warrant did not show the date it was read to me according to my attorney.

"The seventh item is that at my preliminary hearing in Memphis I was not advised of my right to counsel.

Shelby Co. Criminal Court Div. 3, in Memphis on Oct. 15, 1965 made statements showing he does not uphold the constitution of the United States. I complained of illegal extradition and judge Battle said it didn't make any difference if I was kidnapped or how I got here. I was here, and was held under a true bill of indictment. My attorney stated that my constitutional rights had been grossly violated and the judge said that just because a few of my rights had been violated did not mean he could turn me loose. The judge allowed that some endence illegally (in my opinion) obtained could be presented in his court
