Harold:

I tend to follow your judgment on these matters, but understand what I want. A solod hit the first time--ZANG, right in the keester, no compromize with fact. Once we are satisfied that we are right, we offer take-it-or-leave-it deals. I know that I do not have to argue with you about any of this sort of attitude, but I want you to know what I am willing to go for.
