Harold:

I have much of your correspondence to comment on, but not time to do it all thoroughly. Please excuse if I omit some things. The topics follow no fixed order-- just whatever comes into my hands.

6.5 M*C velocity: In comparison with other military ammo, this is among the ~~lowest~~ lowest in velocity. In the class of military ammo, I would unequivocally call this very low velocity. This refers to ammo available when the M-C was developed and subsequently-- prior to World War I there were slower military rounds, but not many. At the time of M-C development and later it was and remains among the slowest. Of military ammo, I think only the 5.6 Japanese Arisaka is as low, and I can think of none lower (I do not have ballistic tables before me-- I'll give you exact figures if you want. Instead, he says this (Newsweek): "I would describe them as isolated incidents," declared Deputy Attorney General Richard Kleindienst, who is ordinarily sharply critical of radical ~~explants~~. "I would not exaggerate their importance. I do not connect them with the radical movement." There is only one sort of information that can have inspired that apparent display of fairness-- the information that the bombings were done by rightists.
