Date believed to be 4/15/68; however, the cancellation stamp was quite light and difficult to read and it may be 4/16/68.

It is to be noted that CARTER PITTMAN is a wellknown wealthy segregationist lawyer in Georgia and the CARTER PITTMAN to whom this letter was addressed may be identical __ with this individual.

It is suggested consideration be given to checking out sender of this letter.
