Refuses to Answer About Ties with Nazis

WASHINGTON (AP) — An alleged leader of the American Nazi Party invoked the Fifth Amendment 24 times Wednesday when asked about the distribution of bomb-making information.

James K. Warner, 31, identified at a Senate hearing as national leader of the Sons of Liberty, an affiliate of the American Nazi Party in Los Angeles, refused to answer questions concerning his alleged associations with the Nazis, the national States Rights Party and other rightist groups.

The Senate Investigations subcommittee, headed by Sen. John McClellan, D-Ark., attempted to question Warner as part of its extended hearings into the recent wave of bombings and terrorism in the United States.

ATTORNEY PRESENT

Warner was accompanied by his attorney, J. B. Stoner, National States Rights Party candidate for governor of Georgia.

Though Warner would not talk, the witness who preceded him did.

Donald Sisco, a self-described rightist and former Nazi storm trooper, told of efforts to market his manual for do-it-yourself bombers, "The Militant's Formulaary."

The booklet contains detailed descriptions of the manufacture of explosive and incendiary bombs.

Sisco, who said he is president of Atlan Formulaaries of

Eureka, Calif., said he blew off the fingers of his left hand in the only experimenting with explosives he himself had done.

"I was a storm trooper about a year," Sisco testified. "I was also a member of the Minutemen and the Birch Society."

Asked how he could justify the distribution of a book that could lead to the death of innocent people, Sisco replied: "I wouldn't mind if every right winger in the country had it. It just don't want the left to have it."

The political right exists to destroy the political left, Sisco said, but "until the leftists get rid of the police, we can't get rid of the leftists. We're just waiting and squirreling things away."

"The idea is to utterly destroy the left after it destroys the government," Sisco said.

He denied ever using a bomb himself, said federal controls on explosives would lead to a lucrative black market in dynamite, and told McClellan: "In ten years, you won't be sitting up there — you'll be out fighting in the streets, if you're armed and if you're lucky."

McClellan did not reply.
