SUBJECT : DPD Files Related to Cuban Operations

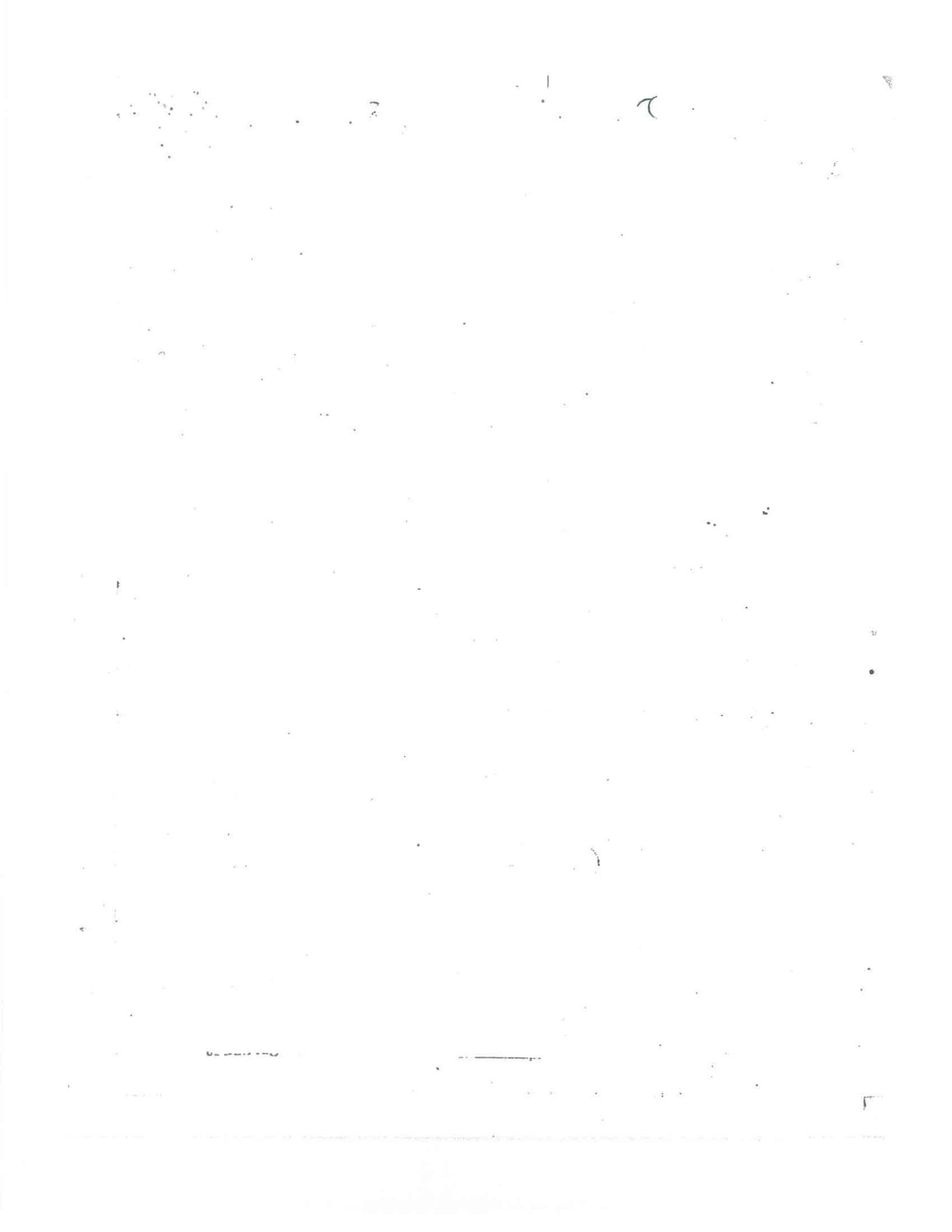
Meeting of Branch 1 Task Force, 9 March 1960

TOPICS: Col. J. C. King, C-13

and other CIA personnel

King told the group that the DOD is presenting a special policy to the UN representatives. He mentioned getting evidence that the Cuban Government has been pushing for an attack on the island of Guantanamo Bay and said that an attack on the island is in fact, possible.

Col. King stated that the major problem in this operation is how to get the word of Cuba to the truth. To date, he said, we have been using of certain American islands that might be useful for either PP or other purposes. In addition, a number of States of friendly countries are at the moment unwilling to assist in this matter. He mentioned that the CASAC regime in Cuba is not willing to assist in this matter. He said that unless Fidel and Raul could be eliminated in one package - which is highly unlikely - this operation may be a long drawn-out affair and the present situation may be a result of the use of force.

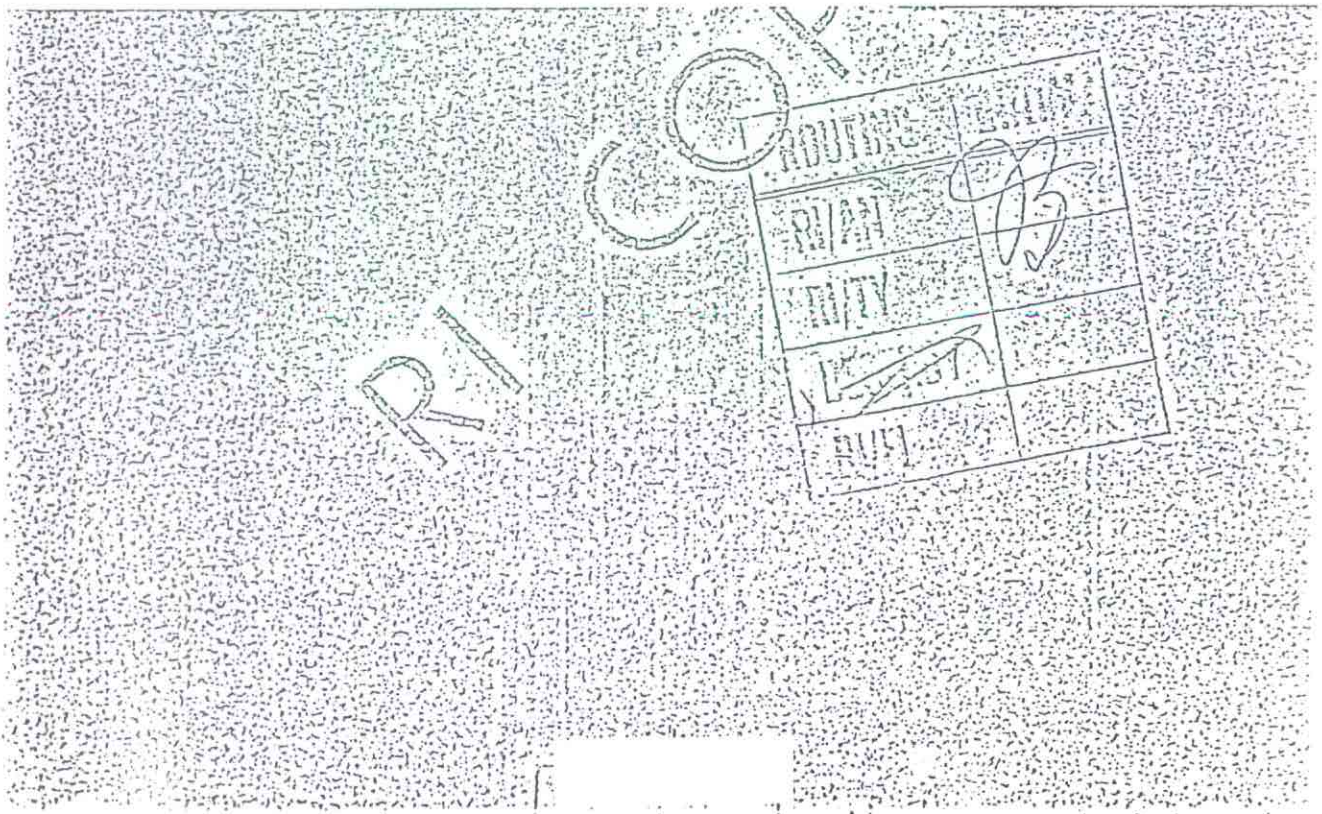
