Secret Service has been identified by an informant of Bradley's as According to Bradley, was transferred from Atlanta, Georgia, to Dallas, Texas, at the time of the assassination of President Kennedy and now is one of the top three men in the U. S. Secret Service. Bradley alleged is providing Harold Weisberg information concerning the FBI, which information is being used in a book written by Weisberg blaming the FBI for the assassination of President Kennedy.

Bureau files indicate Bradley is the West Coast representative for Evangelist Carl McIntyre and Bradley was accused by District Attorney James Garrison of New Orleans, as being involved in a plot to assassinate President Kennedy. Bradley has received in the past a large amount of publicity concerning his extradition from California to New Orleans to stand trial in this alleged plot to assaspinate President Kennedy.
