

WHO SHOT GEORGE WALLACE?

C.R.I.C. and DONALD FRIED

Editor's Note: The following is excerpted from a longer research statement on the Wallace assassination by C.R.I.C. (The Citizens Research and Investigation Committee) is a research unit sponsored by the Center for the Analysis of Law Enforcement Practices.

The following preliminary overview of the attempted assassination of Governor George Wallace is based on information supplied by confidential C.R.I.C. informants. The questions, parallels to other assassinations, speculations and conclusions triggered by the events of May, 1972 are, necessarily, at this point, incomplete and await more information.

The public is informed by the establishment media that Arthur H. Bremer, accused would-be assassin of Governor George Wallace of Alabama, a Democratic Presidential candidate, is a disturbed twenty-one year old unemployed ex-busboy and janitors' assistant. Then the first question must be 1) where did Arthur Bremer get the money for his mad scheme to kill George Wallace who, with his double set of body guards and bullet proof speakers' podium, was by far the most heavily guarded of all the candidates? We are here computing Bremer's expenses — from January, when he

last worked in Wisconsin, to May, when he was arrested in Maryland — at the rock bottom rate consistent with his eighteen week, ten state journey toward murder.

Setting to one side the cash outlay for stopping at expensive hotels (the Waldorf-Astoria in New York, the Lord Elgin in Ottawa); automobile repairs for a machine driven constantly for weeks at speeds up to 75 miles per hour in order to keep pace with presidential candidates who flew to their destinations; any miscellaneous expenses such as the records, ammunition found in his car and the expensive clothes Bremer wore into court when he pled not guilty; setting aside all these and any other contingency costs Bremer could not have spent less than five thousand dollars since he was laid off as a janitor's helper in January of this year.

This extremely conservative figure would include the price of the guns he purchased, court fines for speeding and possessing a gun, and the \$135 a month rent for his occasionally used Milwaukee apartment.

Important is the fact that all this while Bremer was ranging far and wide in pursuit of his quarry he was also doubling back to his Milwaukee base of operations. He was seen near old Milwaukee apartment only a week before the Wallace attack and seen in the company of an "untitled man."

On April 7 and 8, 1972, Arthur H. Bremer was staying at the luxurious Waldorf-Astoria hotel in New York City. Candidate Hubert Humphrey was also scheduled to be there on April 7. This would be a curious enough fact were it not over-

shadowed by another fact: Hubert Humphrey, Waldorf-Astoria arrangements were not known to the public. The next day, April 8, Bremer met the Governor on the landing in Michigan, Ferry.

A hotel agent in a Wisconsin-Michigan ferry line reported having seen Bremer on several occasions talking with an older man, set man as the two of them took pack and forth on the ferry boat. Bremer's 500 pound companion, dressed in resembles a man in a suit, was sitting in Daley Plaza on May 12, 1968, and at the shooting of the day, George Wallace was shot.

In summary, Bremer has no record at all of income in 1972; in 1971 his income tax return shows \$1,011 in wages on one, his automobile purchased in September of 1971, cost some \$500 or half of his total income for the 6-12-71 period. Besides Bremer's residence of level makes it legitimate, impossible for him to have followed various presidential candidates' campaign trails and still be seen near his Midwest base of operations throughout April and May. Arthur H. Bremer was flying on Wall as

diving. The first newspaper media coverage reported that three men were involved. One was Bremer. One was a man who was rushed to a hospital. One was a man seen changing license plates on his car in an apartment building lot.

The parallel between the Wallace assassination attempt and the other assassinations of past figures in the past decade are startling. 1: Unexplained money; Lee Harvey Oswald (revelated extensively for

months, was he was unemployed before the killing of John F. Kennedy in Dallas in 1963. James Earl Ray, unemployed, spent close to \$20,000 during the short period before Dr. Martin Luther King's murder in Memphis. The governor, Sherman B. Sifton, who he was treasurer for the shooting of Senator Robert F. Kennedy, had over \$400 in his possession and had been spending freely.

Bremer, then, south from Ottawa on April 7, that same night and for two more nights stayed at the comfortable, respectable, inn in New Brunswick, Maryland, only a mile from the site where Governor Wallace was gunned down one month later.

2: Freedom of an intelligence agency. Arthur Bremer could not have known that Hubert Humphrey would be in his hotel on April 7. He could not have known this without privileged information.

The to-be-secret, completely classified, Grand Corporation file known as "Operation Star" confirms that agents of a conspiracy had penetrated the Secret Service in Dallas in 1963. In the case of Martin Luther King, undercover operative Sam Rife, of New York's Bureau of Special Services, was Mr. X's bodyguard, and as we shall illustrate, another agent was actually apprehended by the police and then, released.

Arthur Bremer could not have known the location of Governor Wallace's Laurel, Maryland snipping center several weeks in advance without intelligence information.

C.R.I.C. also has proof that staying at the Lord Elgin Hotel in Ottawa at the same time as Arthur H. Bremer were members of a United States intelligence agency.

Law enforcement, through the media, has predicated its "lone ray of truth" theory on the fact that Arthur Bremer has now been connected with not only Governor Wallace but Senator Humphrey and McGovern and, in Ottawa, Canada, with President Nixon. This proves, they imply, that there could be no coherent motive for Bremer thus no conspiracy. What the ubiquitous Bremer does prove is the likelihood that he was not surveilling the presidential candidates but rather the new operating procedure of the Secret Service.

When Arthur Bremer drove from Milwaukee to Ottawa then to Laurel Springs and then flew from Laurel Springs to Milwaukee and back, he was not stalking Richard Nixon. The orders that he received in Milwaukee only days before the act had been kept from him so that, compartmentalized in this way, he could not know or tell, all about the target had been George Wallace. Wallace was seen, but the information on other candidates could be used at other bases.

Finally, if one demands to know why Wallace? It was not the motive was the same as in the James Earl Ray case, a record of King killing to cover a race funds and political matter. The nation contributing to the investigation may be sent to the Beverly Hills, California, and Memphis, Tennessee.
