Gov. George Wallace "ontgomery, Alabama

Dear Governor Wallace,

Bremer was part of a conspiracy, today's <u>Parade</u> quotes your wife as believing. I have heard that you hold the same view. So do I.

Of those working in the field of political assassinations I am in all ways senior. My prior experience, which I believe has been an asset, is unique in this field. I am a former investigative reporter, Senate investigator and editor and wartime OSS analyst. My approach is that of a lawyer, with evidence. It is not the approach of a theorist, although I do try to figure out possibilities and probabilities.

Most of my work has been on the JFK and King assassinations. I am James Earl Ray(s investigator. I did the investigating that led to the success in his habeas corpus petition and to the evidentiary hearing where, despite the decision, by a novel approach, we destroyed all themofficial allegations bout how the crime was committed. We did this so successfully that there was no attempt to rebut.

The young lawyer who, regardless of what you may have heard or read has done all the real legal work in the Rey case, is my lawyer in a series of Freedom of Information suits against various federal agencies. I have filed more than anyone of whom I know under this law. Seven cases have gone to court. One is the first of four cited in the Senate debates as requiring the amending of the law. We have dug no dry wells.

There is much evidence in the crime of which you were the victim that dis not public and in my belief can be obtained. I have asked my lawyer to make a simple request for a small portion of this - the withheld pages of Bremer's diary. I have a zerox of the original handwritten version is this interests you. The FEI did not give the local presecutor the first I think seven pages.

There are inferences in your wife's words for which there is support in terms of both scientific probability and those who actually experimented with thems a combination of drugs and psychological methods to be able to central others. This work, by the CIA to my knowledge, crossed over into the use of acoustical methods of remote central. I have perhaps 300 pages of formerly suppressed CIA records on this. Not all have been released publicly. If I am not saying this CIA did this to you, I am saying your wife is not halucinating.

I am also saying I do not now think it is possible to prove more than that there was a conspiracy against you. Who the conspirators were, as in the JFK assassination, I do not expect to be able to prove. There is a possibility in the King case. Forcing a real investigation, which would be the first real investigation in any of the cases, might compel real investigations of all.

If I can be of help to you I am willing to do what I can. If you want credentials on me, although I have not asked their permission, I can refer you to people from Les Whitten to Bill Loeb of the Manchester <u>Union-Leader</u> and to thousands of pages of court records that include the FBI's certification to a federal district court that I know more about this subject than it does.
