- 1. By amending the title of this action to read as follows:
- Dr. Carlos Bringuier Vs. Gambi Publications, Inc., Harold Weisberg, and Dell Publishing Co., Inc.
 - 2. By amending Paragraph II to read as follows:

II.

The Gambi Publications, Inc., a defendant herein, is a New York corporation with offices at 30-30 Northern Blvd., Long Island City, New York, which is not qualified to do business in Louisiana, but is doing business in the State because of the sale and distribution of the magazine "Saga", Harold Weißberg, a defendant herein, residing at Coq D'Or Farm, Hyattstown, Maryland, who conducts business in the State of Louisiana by virtue of the sales in Louisiana of his book "Whitewash-The Report on the Warren Report", is the author of the article "Kennedy's Murder-Buried Proof of a Coaspiracy", which article appears in the April, 1967, edition of Saga Magazine, designated as volume 34, No. 1, and by virtue of his being the author and publisher of the book entitled "Whitewash-The Report on the Warsen Report", which book has been widely sold and distributed in the State of Louisiana, and Dell Publishing Co., Inc., a New York corporation, with offices at 750 Third Avenue, New

York, New York, a publisher of the book entitled "Whitewash-The Report on the Warren Report", which book has been widely sold and distributed in the State of Louisiana, are justly and truely indebted unto petitioner, jointly, severally and in solido, in the full sum of One Million Dollars (\$1,000,000.00) for the reasons hereand after set forth.

- 3.- By amending Paragraph III. By deleting therefrom the word "Commission" which appears partially on line two and partially on line three thereof.
- 4. By adding an additional paragraph following Paragraph III, to be numbered Paragraph III (A), as follows:

the aforesaid Harold Weisberg, the author and a publisher of the book "Whitewash-The Report on the Warren Report", and that said book was published and printed subsequent to 1965, and said book was widely distributed, sold, and read in the New Orleans area, the State of Louisiana, throughout the United States and in foreign countries.

5. - By adding an additional paragraph following Paragraph III (A), to be numbered Paragraph III (B), as follows:

III. (B)

That the Dell Publishing Co., Inc., a publisher of the book "WhitewashThe Report on the Warren Report", commenced publishing said book during
1966 with a total of four separate printings to date, and that said book was
widely distributed, sold, and read in the New Orleans area, the State of Louisiana, throughout the United States and in foreign countries.

- 6. By amending Paragraph IV by deleting the word "Commission" from line two thereof.
- 7. By amending Paragraph V by deleting therefrom the word "Commission", and I contained partially on line two and line three thereof.
- 8. By amending Paragraph IX by substituting the word "libel" for the word "liable" appearing on the first line thereof.
 - 9. By amending Paragraph X to read as follows:

X.

Petitioner avers that, under the law, he is entitled to trial by jury; and that he desires to have this cause tried by a jury. WHEREFORE: petitioner prays that after due proceedings defendants, Gambi Publications, Inc., Harold Weisberg, and Dell Publishing Co., Inc., be condemned to pay to the petitioner the sum of One Million Dollars (\$1,000,000.00) with legal interest from judicial demand until paid, and all costs of this suit.
