Dear Mr. Bair,

Thanks for your letter of June 8.

I plan to be in New Orleans within two or three months, which you ask me, but I do not know when. A week ago Jim Garrison asked me if I could go there within a couple of weeks, but I do not think I will. I want to complete other writing first.

However, if you or Mr. Lucas would like, I will be happy to meet him in Washington the week of June 19, if it is on June 21 or earlier. I must be away the rest of that week. Should he or you like, I can meet him at the airport and drive him to his hotel. Perhaps this will be all the time he might require to talk with me.

The other plans you report meet with my approval.

If your initial move is successful and you plan to go further along the lines we discussed by phone, which is the personal preference ~~preference~~ of Martin Singer, editor of "Saga", please let me know and I will cooperate to the degree I can. I have all the documents in the Commission's files relating to him and you are welcome to them, for whatever use you may desire.

If it is not initially successful and Mr. Lucas wants copies, I will provide them to him. In this event, should he desire, I will also arrange to Xerox all the applicable parts of Bringuier's testimony and exhibits for you and him.

Although my plans for going to New Orleans are indefinite, to be of as much assistance as possible to Mr. Lucas, let me so that my current estimate is that in about a month I will make a brief trip there and about a month and a half later I'll go there for a longer stay.

Dear Mr. Weisberg:

After discussions with Louisiana counsel, we have recommended to him that he immediately move to quash service of process on all three defendants, reserving the right to move against the interrogatories served on all defendants if service of process is upheld. In connection with this motion, it will be necessary for all defendants to file affidavits with the Court stating their lack of contact with Louisiana. A draft of your affidavit will be forwarded to you for consideration in due course.

In the event that we are unsuccessful in attacking the jurisdiction of the Court, it will probably be necessary for you to meet with Mr. Lucas of Dufour, Levy, Marx and Lucas, to discuss the case. Please let me know if you plan to be in or around New Orleans within the next two or three months. If not, Mr. Lucas will be in Washington on other business the week of June 19th, and we will arrange a meeting at that time.
