AT T-TWO, IDENTIFIED ON COVER PAGE AS BLANEY MACK JOHNSON, WHOSE IDENTITY
WAS NOT SHOWN IN REPORT AT HIS REQUEST.

INFORMATION ATTRIBUTED TO THE INFORMANT IS SUBSTANTIALLY THE
SAME AS THAT IN ATLANTA TELETYPES NOVEMBER TWENTYNINE AND THIRTY,
SIXTYTHREE, TO MIAMI AND DALLAS, BEARING RUBY CAPTION. MIAMI
TELETYPES NOVEMBER THIRTY AND DECEMBER ONE, SIXTYTHREE UNDER RUBY
CAPTION SET FORTH INTERVIEWS WITH LEF T. LEWIS (SHOWN AS LESLIE
LEWIS IN REREP AND ATLANTA TEL NOVEMBER THIRTY), JOSEPH
G. HARRIS AND CLIFTON T. BOWES, JR., ALL OF WHOM DISCREDITED
INFORMATION FROM ATLANTA INFORMANT. ATLANTA INFORMANT ALSO NAMED

IN VIEW OF INFORMATION IN MIAMI TELS WHICH NEGATED INFORMATION FROM ATLANTA INFORMANT, INFORMATION IN MIAMI TELS HAS NOT BEEN SUBMITTED IN REPORT FORM TO DATE AND, ACCORDINGLY, PRESIDENT'S COMMISSION, WHILE RECEIVING REFERENCED ATLANTA REPORT, HAS NOT RECEIVED THE ADDITIONAL INVESTIGATION.

BUAIRTEL APRIL NINE, SIXTYFOUR, TO DALLAS TRANSMITTED REQUEST OF PRESIDENT'S COMMISSION THAT ALLEGATIONS OF ATLANTA INFORMANT BE FULLY RESOLVED AND REPORTED TO THEM. BUREAU INSTRUCTS AUXILIARY OFFICES IMMEDIATELY PREPARE FD THREE ZERO TWO'S ON INTERVIEWS CONDUCTED BY THEM AND FURNISH TO DALLAS BY RETURN AIRTEL FOR INCLUSION IN DALLAS REPORT. REQUEST TWENTY COPIES OF FD THREE ZERO TWO'S.

MIAMI IMMEDIATELY FURNISH FD THREE ZERO TWO'S REFLECTING INTERVIEWS WITH BOWES, LEWIS AND MARRS. NOTE BOWES SPECIFICALLY

ATLANTA IMMEDIATELY INTERVIEW EDDIE BROWDER IF NOT
ALREADY DONE TO DETERMINE IF IDENTICAL DONALD EDWARD BROWDER.
IF NOT IDENTICAL, CONDUCT NECESSARY INVESTIGATION TO IDENTIFY
AND INTERVIEW.

ATLANTA REINTERVIEW BLANEY MACK JOHNSON AND CONFRONT
HIM WITH FACT PERSONS NAMED BY HIM AS HAVING KNOWLEDGE OF
ALLEGATIONS MADE BY HIM HAVE DENIED SUCH ARE TRUE. SUGGEST
ATLANTA INFORM JOHNSON HIS IDENTITY CANNOT BE FURTHER CONCEALED
AND THAT FD THREE ZERO TWO OF REINTERVIEW REFLECT HE IS IDENTICAL
WITH BY J-TWO. IF THIS IS LOGICAL AND CAN BE ARRANGED, ATLANTA
SUTEL MIAMI SO JOHNSON'S NAME CAN BE INCLUDED IN MIAMI FD THREE
ZERO TWO'S.

IT APPEARS ORIGINAL DATES OF DICTATION AND TYPING
SHOULD BE USED FOR FD THREE ZERO TWO'S.
