The "suspect individuals" pertaining to the assassination of President John Fitzgerald Kennedy emanated from certain radio transmissions of the Dallas, Texas, County Sheriffs Office and the Dallas Police Department on November 22, 1963.

Referenced letter asked for comments of the FBI concerning Mr. Brown's request. To obtain the data Mr. Brown is interested in, would require a considerable amount of research into voluminous FBI files concerning the assassination of President Kennedy. We do not have sufficient personnel to conduct the necessary research to comply with requests of this type; therefore, no further action is being taken in this matter.
