Only with the Congressional Committee in the news has there suddenly been a rash of articles. How do you assess the Committee and Mr.Sprague? Will you attempt to address Mr.Sprague or any of the committee? I would certainly hope someone in the group has read POST MORTEM. I do know Congressman Gonzalez did the forward to Coup De Tate in America, that piece of junk by Weberman.

I've enclosed an ad for a book titled, THE ASSASSINATION CHAIN by Sybil Leek and Bert Sugar. I haven't seen it, have you? SIX SECONDS IN DALLAS, is now out in paperback. On this note, I have enclosed an article from The New York Post called "Making a Buck on the Death of a President". I think you'll enjoy the article. According to the article, Bernard Fensterwald will have a book out on the JFK murder (published by Zebra books, who also published Hugh MacDonald's "solutiom").

What do you make of the story about Oswald conversation with persons at the Soviet Embassy? Why do you suppose it was leaked and by whom? It doesn't seem to have come from the committee.
